6. RECEIVE THE GOVERNMENT FINANCE OFFICERS' ASSOCIATION CERTIFICATE OF ACHIEVEMENT FOR EXCELLENCE IN FINANCIAL REPORTING – Samir Sheikh, Executive Director/APCO, announced that the District has been awarded the Government Finance Officers' Association of the United States and Canada (GFOA) Certificate of Achievement for Excellence in Financial Reporting for the District's Annual Comprehensive Financial Report (ACFR) for the fiscal year ending June 30, 2020. He also recognized Mehri Barati, Director of Administrative Services, and Ryan Buchanan, Controller, and thanked them and their Finance team for all of the hard work they do and the Board for their leadership and making fiscal transparency a priority for the agency.

Chairman Pedersen thanked staff and said he wanted them to know how much the Board appreciates their efforts because it is critical that the District is transparent in how the public funds entrusted to the agency are utilized.

Dr. Sherriffs echoed Chairman Pedersen's comments and said what the Finance team is doing in terms of reinforcing the work that the District is doing is critical as we are dealing every year with hundreds of millions of dollars of public funds where transparency is key and critical to getting additional funding.

Supervisor Mendes said it is very important to have such a great team that is transparent and accurate in accounting for District funding.

7. STATE IMPLEMENTATION PLAN CREDIT FOR RESIDENTIAL WOOD
BURNING DEVICE CHANGE-OUT INCENTIVE MEASURE – Mr. Sheikh said
the next two items were related to the District's ongoing work in implementing the
wide variety of measures that are included in the 2018 PM2.5 Plan. He
introduced Jessica Coria, Program Manager, who presented the proposed Burn
Cleaner Fireplace and Woodstove Change-out Incentive Measure for inclusion in
the State Implementation Plan.

Chairman Pedersen said this is clearly one of the identifiable programs in the community that truly helps. He reminded staff that there are many of residents who are not familiar with or comfortable using online tools to apply for programs like these and asked them to ensure there are alternative ways to participate. Mr. Sheikh responded that staff is very sensitive to the fact that different residents have different needs in seeking this funding. He said the District accepts applications via paper, in person, and can also provide assistance to residents over the phone.

Supervisor Mendes asked if there was readily available equipment for residents. Mr. Sheikh responded that staff is definitely hearing about supply chain issues when it comes to a variety of equipment or devices. He said staff are engaged in very active discussions with retailers to understand the impacts. He said there is still quite a bit of demand and continued implementation of projects under the programs. In regards to heavy duty equipment, he said staff is actively talking to

state agencies and some of the big manufacturers to make sure, to the extent they can prioritize equipment in areas like ours with air quality challenges, that we are looking at ways within supply chains to direct priority procurement. Chairman Pedersen commented on inflation bringing additional challenges.

Supervisor Wheeler commented on outreach efforts for the additional funding available. Mr. Sheikh responded the District conducts a very aggressive outreach campaign every year, utilizing a variety of marketing resources including social media, television, and other avenues to promote the program. In addition, he said staff works with retailers to make sure they have marketing materials. He recognized Mayor Pro Tem Lewis for her leadership and laying the groundwork for program outreach for retailers in her County. Supervisor Wheeler asked staff to provide him with outreach materials to share on his social media pages.

Supervisor Shuklian said she was a big proponent of this program and noted that one of the commercials she filmed had a tagline for replacing wood burning devices.

Mayor Reyes suggested conducting more outreach with Valley chambers of commerce, who typically have a good relationship with residents and use conventional outreach methods.

Mayor Pro Tem Lewis said she truly enjoys her gas fireplace and is encouraging residents within Merced County to participate in this program and take advantage of the available funding.

Dr. Sherriffs commented this was obviously a fabulous program in terms of bang for the buck and what we get back direct PM reductions. He asked how the surplus value of reductions would be calculated since this this is voluntary program where people are actually choosing gas over wood, as well as taking people who could not burn and providing a window for them to burn. In addition, he asked how to ensure this choice was permanent so that residents could not choose to go back to a wood burning device. Mr. Sheikh responded that a lot of effort goes into implementing a SIP-creditable grant program, including quantifying reductions. He said it also takes into account that we have a very strict regulatory program and the restrictions on burning are strongly considered. He said there are numerous measures in place to ensure transparency and ensuring that all projects are completed. He said staff has worked closely with EPA and CARB to ensure this program meets all of the requirements for this SIP-creditable program. He said the program would also enable the Valley to exceed the commitment in our plan with even more projects to come.

Mayor Preciado voiced his full support for this program.

Supervisor Pareira asked staff to send Board members the list of retailers for this program so that they can share with constituents in their jurisdictions.

8. STATE IMPLEMENTATION PLAN CREDIT FOR ADOPTED AGRICULTURAL BURNING PHASE-OUT STRATEGY – Jon Klassen, Director of Air Quality Science and Planning, presented this item and recommended the Board approve District Rule 4103 (Open Burning) Technical Submittal for Receiving SIP Credit for Reductions in Agricultural Burning.

Supervisor Mendes commented on equipment that needs on board computer systems and asked about supply chain issues to the trouble getting computer chips.

Mr. Sheikh responded this directly effects the expansion of the chipping services to make sure they are able to respond to the significant new demand from growers throughout the Valley. He said the Board included some funding for an infusion of extra equipment into the fleets and staff have worked very hard on pushing the local dealerships and manufacturers of this equipment to see what could be done to make them more quickly available to the Valley.

Supervisor Mendes asked about tier-5 engines and when they might be coming online. Mr. Sheikh responded that the jury was still out and there were a lot of developments that needed to take place before that equipment was made available.

Dr. Sherriffs commented on the problems with the biomass industry and asked about the permanence and ensuring we are not in danger of sliding back or facing issues in the future that would require reinventing the wheel.

Mr. Sheikh responded the Board already adopted the regulatory strategy for this program, and this item was strictly about quantifying the emissions reductions

that come from that regulatory strategy.

Chairman Pedersen thanked the Community Steering Committees and staff for their hard work. He said it is important that this program developed by the State Legislature, continues to be funded.

Dr. Sherriffs reiterated the tremendous comments provided by community members and thanked staff for their hard work and robust engagement. He added if there were state resources that are going to support more AB 617 communities in the future, clearly the Valley is well positioned to be at the head of the line.

10. - 12. <u>EXECUTIVE DIRECTOR/APCO COMMENTS</u> Mr. Sheikh updated members on the major developments with respect to climate initiatives and big funding opportunities that may arise to help the Valley continue to pursue innovative measures that will help the District deal with various climate goals as well as our local clean air issues. He said there has been a lot of activity with respect to the

adoption of the federal infrastructure bill that includes significant funding for a variety of things and provides a lot of opportunity in our region to take advantage of that funding. He said the other big opportunity is the development of the state's budget and said work has begun advocating for priorities and needs of the Valley.
