On July 18, 2003, Hearing Board Chairman, James V. Glaser, MD, approved an emergency variance effective from July 11, 2003, to August 10, 2003. Said variance provided relief from the requirements of District Rules 2010 and 4701, as they pertain to the postponement of the required District-witnessed compliance source test of a 415 horsepower natural gas-fired internal combustion engine due to the unforeseen failure to fuel ration controller.

On August 1, 2003, Hearing Board Chairman, James V. Glaser, MD, approved an emergency variance effective from August 2, 2003, to September 1, 2003.
