Patrick Houlihan, Senior Air Quality Specialist, presented the staff report. He stated Wellhead Power Panoche, LLC (WPP) is requesting a short term variance. He reported WPP plans to swap out the 'B' turbine with a unit that will be leased until the original turbine can be repaired. It is

expected compliance with emission limits will be achieved, however, WPP will still need a variance relief to re-install the original turbine and perform reliability checks. WPP must apply for a Temporary Replacement Equipment Unit (TREU) PTO from the District before installing the leased turbine. This will take approximately a month to obtain the TREU and locate a suitable turbine.

Mr. Houlihan noted a change in the dates submitted in Condition #1. The effective dates in Condition #1, page 4 should read October 5, 2009 to December 3, 2009.

The Hearing Board members determined that the listed findings have been made and to grant a short variance to Wellhead Power Panoche, LLC, subject to the conditions as listed in the staff report.

Patrick Houlihan, Senior Air Quality Specialist, presented an amended staff report. He stated PPG Industries, Inc. is requesting a short term variance. He reported Rule 4354-Glass Melting Furnaces requires glass plants to install PM10 monitoring equipment or choose an alternate monitoring parameter by January 1, 2011. He added PPG has indicated the monitoring equipment does not currently exist in the market place, consequently, PPG has chosen a parametric monitoring scheme whereby they will monitor and record the voltage of the EP. PPG is requesting a variance relief to source test the EP at lower voltage levels, however, PPG does not know what level to set the EP at without exceeding the permitted PM10 limit. He also stated a violation will occur if PPG picks a level that is too low, and they will have to set the voltage higher and retest. In

addition, if the sources test goes as planned, PPG will only need one day to complete the testing.

Patrick Houlihan, Senior Air Quality Specialist, presented the staff report. He stated due to the continued economic downturn, PPG is set to produce record low amounts of product. PPG is requesting the variance to provide relief from the way that the Permit to Operate (PTO) requires PPG to calculate NOx. The PTO requires PPG to calculate NOx on a pound per ton of glass pulled. He reported PPG will violate the NOx pound per ton of lass pulled PTO limit, and wish to report emissions in pounds per day, in conjunction with the PTO requirement to report pounds per ton of glass pulled. PPG has stated that their daily emission limit will not be violated.
