- 10. The Northern Region Hearing Board heard and granted the following emergency variances since the October 4, 2017, hearing:

A. <u>N-17-20E</u> - Owens-Brockway Glass Container Inc.

On November 17, 2017, Hearing Board Chair, Mr. Mark Kanai, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from November 17, 2017, through November 23, 2017. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4401, 4354, and allowed for continued operation of Furnace A and the manufacture of glass while the exhaust bypasses the add-on emissions control systems and the CEMS/COMS until the repair work on the induced draft fan bearing and exhaust ductwork is completed.

B. N-17-21E - Pacific Ethanol Stockton

On December 1, 2017, Hearing Board Vice-Chair, Mr. Gerald Schneider, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from December 2, 2017, through December 2, 2017. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, and 4623 and allowed for continued fermentation of ethanol while the two wet scrubbers are off-line.

C. N-18-01E - Pacific Ethanol Stockton
