5. Emergency Variances:

The Southern Region Hearing Board approved the following emergency variance order:

A. Docket #S-04-57E – Taft Manufacturing Company

On October 13, 2004, Hearing Board Chairman Mr. Hollis Carlile approved an emergency variance effective from October 13, 2004, to October 19, 2004. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, and 4451 to allow the acrolein manufacturing plant to open reactors, quench towers, condensers, heat exchangers and storage vessels to the atmosphere in order to conduct cleaning activities.

B. Docket #S-04-59E – Equilon Enterprises LLC

On October 27, 2004, Hearing Board Chairman Mr. Hollis Carlile approved an emergency variance effective from October 28, 2004, to November 26, 2004. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, and 4623 to allow the refinery to continue operations while the #6 and #7 vapor recovery systems are shutdown to perform maintenance and repair activities on the flare header.

C. Docket #S-04-61E – Equilon Enterprises LLC

On October 27, 2004, Hearing Board Chairman Mr. Hollis Carlile approved an emergency variance effective from October 26, 2004, to November 24, 2004. Said variance provided relief from specific requirements of District Rules 1080, 2070.7.0, and 2201 to allow the refinery to continue operations while continuing to investigate and troubleshoot polling issues with the Continuous Emissions Monitoring System.
