- 6. <u>APCO/DEPUTY APCO COMMENTS</u> Morgan Lambert, Deputy Air Pollution Control Officer, gave updates on the following:
  - Adoption of Community Emissions Reduction Programs for AB 617 Communities of Shafter and South Central Fresno
  - Approval of additional funding for On-Field Alternatives to the Open Burning of Agricultural Materials Incentive Program
  - The District is seeking to fill 2 vacancies on EJAG: (1) Ethnic, Small Business Owner – may reside in any of the 8 counties in the SJV; and (1) Merced County At-Large member
  - Currently the next upcoming EJAG Meeting is scheduled for December 26, 2019. Recommendation is to move the December meeting to January 23, 2020, and to move all future December meetings to the month of January instead of December
- 7. <u>UPDATES ON ATTAINMENT PLANS AND RULES</u> Jessica Coria, Program Manager in the District's Air Quality Science and Planning Department, provided an update on the District's attainment plan and rule making efforts.
- 8. AB 617 UPDATE Ms. Coria provided an update on the AB 617 Community Emissions Reduction Programs (CERPs). The CERPs address community air quality issues and concerns, including measures to reduce emissions from heavy duty mobile sources, automobiles, agricultural sources, industrial sources, and residential sources; reduce exposure through indoor air filtration, vegetative barriers; anti-idling messaging, outreach and education about air pollution sources and impacts; work with other agencies to address concerns not within District's jurisdiction (land use, pesticides, urban greening, etc.). She reported the Governing Board adopted the Community Emission Reduction Plans (CERPs) on September 19, 2019. The adopted CERPs have been forwarded to CARB for their consideration as required by state law. CARB will hold workshops in the communities in November and hold a hearing in February to approve the CERPs.

Also at their meeting on September 19, 2019, Ms. Coria reported the Governing Board also made recommendations to CARB on Valley communities for future inclusion in AB 617. The Board recommended that Southwest Stockton be selected by CARB for second-year resources for the development of community

air monitoring and emissions reduction programs. Should more funding become available that would allow CARB's selection of more communities without diluting the necessary resources for implementation of AB 617 programs in the existing communities, the District also recommended strong consideration for Arvin/Lamont as a second Valley community for consideration.

9. <u>INDOOR AIR QUALITY</u> – Jon Klassen, Director of Air Quality Science and Planning, provided an update on indoor air quality and recent efforts aimed at reducing exposure and potential impacts.

Mr. Smith asked for more clarification on ventilation. Mr. Klassen explained that if there was a situation where a wildfire was occurring, then ventilation would not be recommended. He added it can be a complicated issue and is dependent on the circumstances, as emissions inside a building or home can build up over time. He suggested if the outside air quality was good then ventilation should be considered.
