

Tune In Tune Up participants who have been determined to be qualified for EFMP and Plus Up funding by authorized District representatives are eligible for the following incentives based on income limits, type of vehicle purchased, and residential status in a disadvantaged community.

Table 1 - Eligibility for EFMP or Plus Up is based on the following household income limits.
