- Emissions from this IC engine shall not exceed 0.127 g-PM10/bhp-hr based on USEPA certification using ISO 8178 test procedure. [District Rules 2201 and 4102 and 13 CCR 2423 and 17 CCR 93115 and 40 CFR 60 Subpart IIII]

- 10. This engine shall be operated only for testing and maintenance of the engine, required regulatory purposes, and during emergency situations. Operation of the engine for maintenance, testing, and required regulatory purposes shall not exceed 50 hours per calendar year. [District Rule 4702 and 17 CCR 93115]
- 11. The combined hours of non-emergency operation (testing and maintenance of the engine, and required regulatory purposes) for this unit and permit unit N-8152-2-0 shall not exceed 5.5 hours in any rolling 24 hours period. [District Rules 2201 and 4102]
