#### I. PROPOSAL

O'Neill Beverages Co. LLC is proposing a Title V significant permit modification to incorporate Authorities to Construct C-629-430-3 and '-431-3 into the Title V operating permit. The ATCs encompass the installation of two (2) new winery tanks. The details are stated in Section VI of this document.

The purpose of this evaluation is to identify all applicable requirements, determine if the facility will comply with the applicable requirements and to provide the legal and factual basis for the proposed revisions.

### IV. SCOPE OF EPA AND PUBLIC REVIEW

This change to a Title V permit is considered to be a significant modification because the ATC's issued were part of a Federal Major Modification and the applicant did not originally apply for a Certificate of Conformity (COC) with the original New Source Review (NSR) Authorities to Construct (ATCs). As such, this project requires public review.

### V. APPLICABLE REQUIREMENTS

District Rule 2520, <u>Federally Mandated Operating Permits</u> (Adopted June 21, 2001)

### VI. DESCRIPTION OF PROPOSED MODIFICATIONS

O'Neill Beverages proposes incorporation of two (2) Authorities to Construct, previously issued for construction of new winery tanks, into the Title V permit. A description of the proposed modifications is described below:

### C-629-430-4 and '-431-4

- Conditions 6-21 of the ATC appear as conditions 1-16 of the PTO.
- Conditions 1 and 2 of the ATC are satisfied by the Title V application submitted for this project and were thus deleted.
- Condition 3 of the ATC was not placed on the PTO since this condition is present in the facility-wide requirements for this stationary source.
- Conditions 5 and 6 have been satisfied by District ERC withdrawal project S-1114021 and were thus deleted.

### VII. COMPLIANCE

District Rule 2520, Section 6.0 describes the source's ability to make changes including significant permit modification. This modification does not meet the minor permit modification criteria pursuant to Section 3.20 described as follows.

1. Do not violate requirements of any applicable federally enforceable local or federal requirement;

- 2. Do not relax monitoring, reporting, or recordkeeping requirements in the permit and are not significant changes in existing monitoring permit terms or conditions;
- 3. Do not require or change a case-by-case determination of an emission limitation or other standard, or a source-specific determination for temporary sources of ambient impacts, or a visibility or increment analysis;
- 4. Do not seek to establish or change a permit term or condition for which there is no corresponding underlying applicable requirement and that the source has assumed to avoid an applicable requirement to which the source would otherwise be subject. Such terms and conditions include:
  - a. A federally enforceable emission cap assumed to avoid classification as a modification under any provisions of Title I of the Federal Clean Air Act: and
  - b. An alternative emissions limit approved pursuant to regulations promulgated under section 112(i)(5) of the Federal Clean Air Act: and
- Are not Title I modifications as defined in District Rule 2520 or modifications as defined in section 111 or 112 of the Federal Clean Air Act; and
- 6. Do not seek to consolidate overlapping applicable requirements.

In accordance with Rule 2520, the application meets the procedural requirements of Section 11.3 by including;

- 1. The identification of the source, the name and address of the permit holder, the activities and emissions change involved in the permit action;
- 2. The name and address of the District, the name and telephone number of District staff to contact for additional information:
- 3. The availability, upon request, of a statement that sets forth the legal and factual basis for the proposed permit conditions;
- 4. The location where the public may inspect the complete application, the District analysis, the proposed permit, and all relevant supporting materials:
- 5. A statement that the public may submit written comments regarding the proposed decision within at least 30 days from the date of publication and a brief description of commenting procedures, and
- A statement that members of the public may request the APCO or his designee to preside over a public hearing for the purpose of receiving oral public comment, if a hearing has not already been scheduled. The APCO shall provide notice of any public hearing scheduled to address the proposed decision at least 30 days prior to such hearing;

The annual VOC wine storage emission factor for each wine ethanol content shall be calculated using the following equation: EF = 1.705259 \* P^1.090407; where EF is the VOC emission factor in pounds of VOC per 1000 gallons of wine throughput; and P is the volume percent ethanol of the wine being transferred. [District Rule 2201]
- 8. Combined annual VOC emissions from wine storage operations under permit units C-629-383 through C-629-431 shall be determined as the sum of the emissions for each individual wine movement based on the volume transferred in each wine movement and the batch-specific wine storage emission factor calculated using the equation(s) specified within this permit. [District Rule 2201]
- 9 The VOC emissions rate for fermentation operations in this tank shall not exceed 3.46 lb/day per 1000 gallons of tank capacity. [District Rule 2201]

- 17. The average fermentation temperature of each batch of must fermented in this tank shall not exceed 95 F, calculated as the average of all temperature measurements for the batch taken at least every 12 hours over the course of the fermentation. [District Rule 4694]

For each batch of must fermented in this tank, the operator shall record the fermentation completion date, the total gallons of must fermented, the average fermentation temperature and the uncontrolled fermentation emissions and fermentation emission reductions (calculated per the emission factors given in District Rule 4694). The information shall be recorded by the tank Permit to Operate number and by wine type, stated as either red wine or white wine. [District Rules 2201 and 4694]

When this tank is used for wine storage, daily throughput records, including records of filling and emptying operations, the dates of such operations, a unique identifier for each batch, the volume percent ethanol in the batch, and the volume of wine transferred, shall be maintained.
