The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to Guardian Industries Corp. for emission reductions generated by the cold tank rebuild of the flat glass furnace, at 11535 E. Mountain View Ave. in Kingsburg. The quantity of ERCs to be issued is 5,286 metric tons of CO2e per year.

Enclosed are the ERC Certificates and a copy of the notice of final action to be published approximately three days from the date of this letter.

Notice of the District's preliminary decision to issue the ERC Certificates was published on March 28, 2013. 
