The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to Farmers Firebaugh Ginning Company for emission reductions generated by the shutdown of a cotton gin, at 35851 West Bullard, in Firebaugh, CA. The quantity of ERCs to be issued is 679 metric tons of CO₂e per year.
