The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to Anderson Clayton Corporation, Butte for emission reductions generated by the shutdown of a cotton gin, at 26865 S. Butte Avenue, in Five Points. The quantity of ERCs to be issued is 241 metric tons of CO₂e per year.

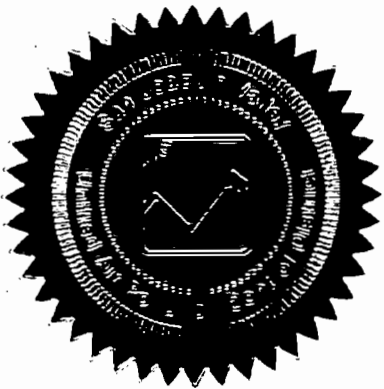
