The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to Anderson Clayton Corp - Los Banos for emission reductions generated by the shutdown of a cotton gin, at 18998 Cotton Gin Road in Los Banos. The quantity of ERCs to be issued is 197 metric tons of CO₂e per year.
