The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to Buttonwillow Ginning Company for emission reductions generated by the shutdown of a cotton gin, at 2536 Buttonwillow Drive, in Buttonwillow. The quantity of ERCs to be issued is 446 metric tons of CO₂e per year.

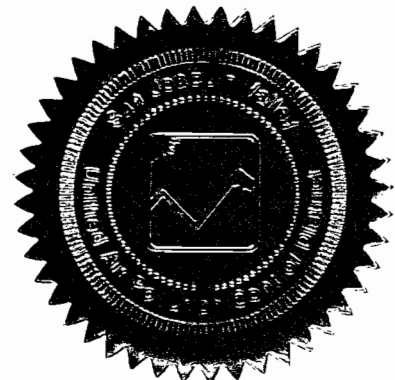
