Enclosed for your review is the District's analysis of your application for a Title V permit significant modification for the facility identified above. Vintage Production California LLC is proposing this modification to incorporate the recently issued ATCs S-8282-30-1, 30-2, 31-1, 33-1, 55-2, 57-1, 58-1, 60-1, and 79-0 into the Title V operating permit (see enclosures). These ATCs authorized various equipment and permit condition changes as described in the attached evaluation.

I. PROPOSAL

Vintage Production California LLC is proposing a Title V significant permit modification to incorporate the recently issued ATCs S-8282-30-1, 30-2, 31-1, 33-1, 55-2, 57-1, 58-1, 60-1, and 79-0 into the Title V operating permit. These ATCs were previously issued to Occidental of Elk Hills, Inc. (OEHI) and were subsequently transferred to Vintage Production California (VPC) through another ATC project. All of the ATCs that were transferred are for modifications of existing equipment or for new equipment for which the applicant had a vested right to proceed, being under the same ownership as OEHI.

VPC, a wholly owned subsidiary of Occidental Petroleum Corporation, is in the business of crude oil and natural gas exploration and production. The equipment within the subject ATCs is used in various forms for oil recovery, processing and storage.

The purpose of this evaluation is to identify all applicable requirements, determine if the facility will comply with the applicable requirements and to provide the legal and factual basis for the proposed revisions.

II. FACILITY LOCATION

The facility is located in the Light Oil Western stationary source (SE ¼ of Section 36, Township 31S Range 23E), in Kern County, California.

This change to the Title V permit is considered a significant modification because it involves the removal of some monitoring requirements. As such, this modification requires public review.

The permit conditions on the proposed modified permits will be revised as follows:

S-8282-30-4:

Permit condition 1 on the current Permit to Operate was deleted. This condition specified a crude oil throughput limit. Since this unit is equipped with a vapor recovery system, the only emissions are fugitive emissions based on the number of components; hence a fluid throughput limit is not required.

Permit condition 2 on the current Permit to Operate was replaced with permit condition 1 on the proposed modified Permit to Operate. This condition specifies the number of transfer pumps included in the operation.

Permit condition 3 on the current Permit to Operate was replaced with permit condition 2 on the proposed modified Permit to Operate, and modified to include Wemco S-8282-109. This condition specifies the permit units sharing the vapor recovery system under S-8282-30.

Permit conditions 4, 5 and 12 on the current Permit to Operate were replaced with permit conditions 6 through 8 and 10 on the proposed modified Permit to Operate. These conditions specify the vapor recovery control efficiency and associated test methods; as well as certain vapor tightness requirements. Permit condition 6 was edited to include a reference for the vapor recovery control efficiency test methods.

Permit conditions 6 and 7 on the current Permit to Operate were deleted. Condition 6 specified a VOC content limit for hydrocarbons in the process stream while condition 7 specified the test method for the VOC content limit. The emission limits have been recalculated based on 100% VOC content (i.e. worst case), hence removing the need for the limit and the corresponding test method.

Permit condition 8 on the current Permit to Operate was replaced with permit condition 4 on the proposed modified Permit to Operate. This condition specifies the calculation method for fugitive VOC emissions.

Permit condition 9 on the current Permit to Operate was replaced with permit condition 3 on the proposed modified Permit to Operate. This condition specifies the VOC limit for fugitive emissions.

Permit condition 10 on the current Permit to Operate was replaced with permit condition 9 on the proposed modified Permit to Operate. This condition specifies the definition of a leak.

Permit condition 11 on the current Permit to Operate was replaced with permit condition 5 on the proposed modified Permit to Operate. This condition requires record keeping of numbers of fugitive emissions components and calculated fugitive emissions.

Permit condition 13 on the current Permit to Operate was replaced with permit conditions 11 through 19 on the proposed modified Permit to Operate. These conditions specify tank inspection and maintenance requirements.

Permit conditions 14 through 24 on the current Permit to Operate were replaced with permit conditions 20 through 22 on the proposed modified Permit to Operate. These conditions specify tank cleaning requirements.

Permit condition 15 on the current Permit to Operate was replaced with permit condition 23 on the proposed modified Permit to Operate. This condition specifies the records retention time.

S-8282-31-2:

Permit conditions 1 through 3 on the current Permit to Operate were replaced with permit conditions 4 through 6 and 8 on the proposed modified Permit to Operate. These conditions specify the vapor recovery control efficiency and vapor tightness requirements. Permit condition 4 was edited to include a reference for the vapor recovery control efficiency test methods.

Permit condition 4 on the current Permit to Operate was replaced with permit conditions 9 through 17 on the proposed modified Permit to Operate. These conditions specify tank inspection and maintenance requirements.

Permit conditions 5 through 15 on the current Permit to Operate were replaced with permit conditions 18 through 20 on the proposed modified Permit to Operate. These conditions specify tank cleaning requirements.

Permit condition 16 on the current Permit to Operate was replaced with permit condition 21 on the proposed modified Permit to Operate. This condition specifies the records retention time.

Permit condition 17 on the current Permit to Operate was replaced with permit condition 22 on the proposed modified Permit to Operate. This condition includes a permit shield against 40 CFR subparts K, Ka and Kb.

New permit conditions 1 through 3 have been added to the proposed modified Permit to Operate. These conditions establish VOC emissions limits for fugitive emissions components, VOC emissions calculation method, and fugitive emissions components record keeping requirements.

New permit condition 7 has been added to the proposed modified Permit to Operate. This condition specifies the definition of a leak.

S-8282-33-2:

Permit conditions 1 and 2 on the current Permit to Operate were replaced with permit conditions 4 through 6 and 8 on the proposed modified Permit to Operate. These conditions specify vapor recovery control efficiency and vapor tightness requirements. Permit condition 4 was edited to include a reference for the vapor recovery control efficiency test methods.

Permit conditions 3 and 4 on the current Permit to Operate were deleted. Condition 3 specified a VOC content limit for hydrocarbons in the process stream while condition 4 specified the test method for the VOC content limit. The emission limits have been recalculated based on 100% VOC content (i.e. worst case), hence removing the need for the limit and the corresponding test method.

Permit conditions 5, 6 and 8 on the current Permit to Operate were replaced with permit conditions 1 through 3 on the proposed modified Permit to Operate. These conditions establish VOC emissions limits for fugitive emissions components, VOC emissions calculation method, and fugitive emissions components record keeping requirements.

Permit condition 7 on the current Permit to Operate was replaced with permit condition 7 on the proposed modified Permit to Operate. This condition specifies the definition of a leak.

Permit condition 9 on the current Permit to Operate was replaced with permit conditions 9 through 17 on the proposed modified Permit to Operate. These conditions specify tank inspection and maintenance requirements.

Permit conditions 10 through 20 on the current Permit to Operate were replaced with permit conditions 18 through 20 on the proposed modified Permit to Operate. These conditions specify tank cleaning requirements.

Permit condition 21 on the current Permit to Operate was replaced with permit condition 21 on the proposed modified Permit to Operate. This condition specifies the records retention time.

S-8282-55-3:

Permit conditions 1 and 6 on the current Permit to Operate were replaced with permit conditions 4 through 6 on the proposed modified Permit to Operate. These conditions specify vapor recovery control efficiency and vapor tightness

requirements. Permit condition 4 was edited to include a reference for the vapor recovery control efficiency test methods.

Permit condition 2 on the current Permit to Operate was replaced with permit condition 7 on the proposed modified Permit to Operate. This condition specifies the definition of a leak.

Permit conditions 3 and 4 on the current Permit to Operate were replaced with permit conditions 1 through 3 on the proposed modified Permit to Operate. These conditions establish VOC emissions limits for fugitive emissions components, VOC emissions calculation method, and fugitive emissions components record keeping requirements.

Permit condition 5 on the current Permit to Operate was replaced with permit condition 8 on the proposed modified Permit to Operate. This condition requires the maintenance of an inspection log for component leaks.

Permit condition 7 on the current Permit to Operate was replaced with permit condition 9 on the proposed modified Permit to Operate. This condition requires the categorization of components according to types specified in District Rule 4409.

Permit condition 8 on the current Permit to Operate was deleted. This condition is redundant as it merely references compliance with conditions on the facility-wide permit.

S-8282-57-2 and 58-2:

Permit conditions 1 and 2 on the current Permit to Operate were replaced with permit conditions 4 through 6 and 8 on the proposed modified Permit to Operate. These conditions specify vapor recovery control efficiency and vapor tightness requirements. Permit condition 4 was edited to include a reference for the vapor recovery control efficiency test methods.

Permit conditions 3 and 4 on the current Permit to Operate were deleted. Condition 3 specified a VOC content limit for hydrocarbons in the process stream while condition 4 specified the test method for the VOC content limit. The emission limits have been recalculated based on 100% VOC content (i.e. worst case), hence removing the need for the limit and the corresponding test method.

Permit conditions 5, 6 and 8 on the current Permit to Operate were replaced with permit conditions 1 through 3 on the proposed modified Permit to Operate. These conditions establish VOC emissions limits for fugitive emissions components, VOC emissions calculation method, and fugitive emissions components record keeping requirements.

Permit condition 7 on the current Permit to Operate was replaced with permit condition 7 on the proposed modified Permit to Operate. This condition specifies the definition of a leak.

Permit condition 9 on the current Permit to Operate was replaced with permit conditions 9 through 17 on the proposed modified Permit to Operate. These conditions specify tank inspection and maintenance requirements.

Permit conditions 10 through 20 on the current Permit to Operate were replaced with permit conditions 18 through 20 on the proposed modified Permit to Operate. These conditions specify tank cleaning requirements.

Permit condition 21 on the current Permit to Operate was replaced with permit condition 21 on the proposed modified Permit to Operate. This condition specifies the records retention time.

S-8282-60-2:

Permit conditions 1, 2 and 7 on the current Permit to Operate were replaced with permit conditions 4 through 6 and 8 on the proposed modified Permit to Operate. These conditions specify vapor recovery control efficiency and vapor tightness requirements. Permit condition 4 was edited to include a reference for the vapor recovery control efficiency test methods.

Permit conditions 3, 4 and 6 on the current Permit to Operate were replaced with permit conditions 1 through 3 on the proposed modified Permit to Operate. These conditions establish VOC emissions limits for fugitive emissions components, VOC emissions calculation method, and fugitive emissions components record keeping requirements.

Permit condition 5 on the current Permit to Operate was replaced with permit condition 7 on the proposed modified Permit to Operate. This condition specifies the definition of a leak.

Permit condition 8 on the current Permit to Operate was replaced with permit conditions 9 through 17 on the proposed modified Permit to Operate. These conditions specify tank inspection and maintenance requirements.

Permit conditions 9 through 19 on the current Permit to Operate were replaced with permit conditions 18 through 20 on the proposed modified Permit to Operate. These conditions specify tank cleaning requirements.

Permit condition 20 on the current Permit to Operate was replaced with permit condition 21 on the proposed modified Permit to Operate. This condition specifies the records retention time.

S-8282-79-1:

Permit condition 2 on the Authority to Construct permit was omitted from the proposed Permit to Operate. This condition is already on the facility-wide Permit to Operate.

Permit conditions 4 through 24 on the Authority to Construct permit were added to the proposed Permit to Operate as conditions 1 through 21. Permit condition 4 was edited to include a reference for the vapor recovery control efficiency test methods.

VII. COMPLIANCE

District Rule 2520, Section 6.0 describes the source's ability to make changes including significant permit modification. This modification does not meet the minor permit modification criteria pursuant to Section 3.20 described as follows:

- 1. Do not violate requirements of any applicable federally enforceable local or federal requirement;
- 2. Do not relax monitoring, reporting, or recordkeeping requirements in the permit and are not significant changes in existing monitoring permit terms or conditions;
- 3. Do not require or change a case-by-case determination of an emission limitation or other standard, or a source-specific determination for temporary sources of ambient impacts, or a visibility or increment analysis;
- 4. Do not seek to establish or change a permit term or condition for which there is no corresponding underlying applicable requirement and that the source has assumed to avoid an applicable requirement to which the source would otherwise be subject. Such terms and conditions include;
 - a. A federally enforceable emission cap assumed to avoid classification as a modification under any provisions of Title I of the Federal Clean Air Act; and
 - An alternative emissions limit approved pursuant to regulations promulgated under section 112(i)(5) of the Federal Clean Air Act; and
- Are not Title I modifications as defined in District Rule 2520 or modifications as defined in section 111 or 112 of the Federal Clean Air Act; and
- 6. Do not seek to consolidate overlapping applicable requirements.

In accordance with Rule 2520, the application meets the procedural requirements of Section 11.3 by including:

- 1. The identification of the source, the name and address of the permit holder, the activities and emissions change involved in the permit action;
- 2. The name and address of the District, the name and telephone number of District staff to contact for additional information;
- 3. The availability, upon request, of a statement that sets forth the legal and factual basis for the proposed permit conditions;
- 4. The location where the public may inspect the complete application, the District analysis, the proposed permit, and all relevant supporting materials:
- 5. A statement that the public may submit written comments regarding the proposed decision within at least 30 days from the date of publication and a brief description of commenting procedures, and
- 6. A statement that members of the public may request the APCO or his designee to preside over a public hearing for the purpose of receiving oral public comment, if a hearing has not already been scheduled. The APCO shall provide notice of any public hearing scheduled to address the proposed decision at least 30 days prior to such hearing;

PERMIT UNIT REQUIREMENTS

- The operation shall include up to 6 liquid transfer pumps. [District Rule 2010] Federally Enforceable Through Title V 1.
- The operation shall include vapor piping from tanks T1 (S-8282-30), T2 (S-8282-58), T3 (S-8282-31), T4 (S-8282-33), T5 (S-8282-32), T6 (S-8282-56), T7 (S-8282-57), T8 (S-8282-59), T10 (S-8282-79), Wemco (S-8282-55), and Wemco (S-8282-109) to vapor control system compressor. [District Rule 2201] Federally Enforceable Through Title V Permit
- VOC fugitive emissions from the components in gas and light oil service shall not exceed 0.4 lb/day or 153 lb/year. [District Rule 2201] Federally Enforceable Through Title V Permit
- Fugitive VOC emissions rate shall be calculated using CAPCOA California Implementation Guidelines for Estimating Mass Emissions of Fugitive Hydrocarbon Leaks at Petroleum Facilities Table IV-2c, Oil and Gas Production Screening Value Ranges Emission Factors (Feb 1999), from the total number of components from this tank. [District Rule 2201] Federally Enforceable Through Title V Permit
- Permittee shall maintain records of number and type of components installed and calculated fugitive emissions. Permittee shall update such records when new components are installed. [District Rule 2201] Federally Enforceable Through Title V Permit
- The tank shall be equipped with a vapor loss prevention system capable of collecting all VOC emissions and preventing their emissions to the atmosphere at an efficiency of at least 99% by weight, as determined by the test methods specified in Section 6.4.6 of District Rule 4623. [District Rules 2201 and 4623] Federally Enforceable Through Title V Permit
- Except as otherwise provided in this permit, the operator shall ensure that the vapor recovery system is functional and is operating as designed at all times. [District Rule 2201] Federally Enforceable Through Title V Permit
- All piping, valves, and fittings shall be constructed and maintained in a leak-free condition. [District Rule 4623] Federally Enforceable Through Title V Permit
- A leak-free condition is defined as a condition without a gas leak. A gas leak is defined as a reading in excess of 10,000 ppmy, above background, as measured by a portable hydrocarbon detection instrument in accordance with the procedures specified in EPA Test Method 21. A reading in excess of 10,000 ppmv above background is a violation of this permit and Rule 4623 and shall be reported as a deviation. [District Rule 4623] Federally Enforceable Through Title V Permit
- 10. Any tank gauging or sampling device on a tank vented to the yapor recovery system shall be equipped with a leak-free cover which shall be closed at all times except during gauging on sampling. [District Rule 4623] Federally Enforceable Through Title V Permit

- 11. Permit holder shall keep in their facility at all times a copy of the letter sent to the APCO requesting participation in the Rule 4623 Fixed Roof Tank Preventive Inspection and Maintenance Program, and Tank Interior Cleaning Program, and maintain the records of annual tank inspections, maintenance, and cleaning to document the participation in the program. [District Rule 4623] Federally Enforceable Through Title V Permit
- 12. All piping, fittings, and valves on this tank shall be inspected annually by the facility operator in accordance with EPA Method 21, with the instrument calibrated with methane, to ensure compliance with the leaking provisions of this permit. [District Rule 4623] Federally Enforceable Through Title V Permit
- 13. Operator shall visually inspect tank shell, hatches, seals, seams, cable seals, valves, flanges, connectors, and any other piping components directly affixed to the tank and within five feet of the tank at least once per year for liquid leaks, and with a portable hydrocarbon detection instrument conducted in accordance with EPA Method 21 for gas leaks. Operator shall also visually or ultrasonically inspect as appropriate, the external shells and roofs of uninsulated tanks for structural integrity annually. - 14. Upon detection of a liquid leak, defined as a leak rate of greater than or equal to 30 drops per minute, operator shall repair the leak within 8 hours.
