Dear Mr. Adrian:

The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to H.J. Heinz Company for emission reductions generated by shutdown the entire facility, at 2800 South El Dorado Street in Stockton, California. The quantity of ERCs to be issued is 1,851 metri tons CO2e/yr.

Enclosed are the ERC Certificates and a copy of the notice of final action to be published approximately three days from the date of this letter.

Notice of the District's preliminary decision to issue the ERC Certificates was published on November 4, 2013. The District's analysis of the proposal was also sent to CARB and US EPA Region IX on October 30, 2013. No comments were received following the District's preliminary decision on this project.

Also enclosed is an invoice for the engineering evaluation fees pursuant to District Rule 3010. Please remit the amount owed, along with a copy of the attached invoice, within 60 days.
