Dear Mr. Wheeler:

The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to Hanford LP for emission reductions generated by the shutdown of one 320 MMBtu/hr petroleum coke fired fluidized bed combustor driving a 30 MW steam turbine, at 10596 Idaho Avenue, Hanford, CA. The quantity of ERCs to be issued is 175,579 metric tons CO2e/yr.

Enclosed are the ERC Certificates and a copy of the notice of final action to be published approximately three days from the date of this letter.

Notice of the District's preliminary decision to issue the ERC Certificates was published on April 24, 2014. The District's analysis of the proposal was also sent to CARB and US EPA Region IX on April 21, 2014. No comments were received following the District's preliminary decision on this project.

Also enclosed is an invoice for the engineering evaluation fees pursuant to District Rule 3010. Please remit the amount owed, along with a copy of the attached invoice, within 60 days.
