I. PROPOSAL

NuStar Terminals was issued an Initial TV permit on 1/13/2000. As required by District Rule 2520, the applicant is requesting a permit renewal. The existing Title V permit shall be reviewed and modified to reflect all applicable District and federal rules updated, removed, or added since the issuance of the initial Title V permit.

The purpose of this evaluation is to provide the legal and factual basis for all updated applicable requirements and to determine if the facility will comply with these updated requirements. It also specifically identifies all additions, deletions, and/or changes made to permit conditions or equipment descriptions.

In addition to renewing the Title V permits, Authorities to Construct N-829-5-4, N-32-0, '-33-0, '-34-0, and '-35-0 will be converted into Permits to Operate and incorporated into the Title V permit. The initial requirements for each Authority to Construct, including offset requirements, have been satisfied.

Finally, the following modifications to the permits have been made at the facility's request.

VII. REQUIREMENTS NOT FEDERALLY ENFORCEABLE

For each Title V source, the District issues a single permit that contains the Federally Enforceable requirements, as well as the District-only requirements. The District-only requirements are not a part of the Title V Operating Permits. The terms and conditions that are part of the facility's Title V permit are designated as "Federally Enforceable Through Title V Permit".

VIII. PERMIT REQUIREMENTS

The purpose of this evaluation is to review changes to federally enforceable requirements; therefore, this compliance section will only address rules that have been amended or added since the issuance of the initial Title V permit or most recent renewal of the Title V permit.

A. District Rule 2020 - Exemptions

District Rule 2020 lists equipment which is specifically exempt from obtaining permits and specifies recordkeeping requirements to verify such exemptions. The amendments to this rule do not have any effect on current permit requirements and will therefore not be addressed in this evaluation.

B. District Rule 2201 - New and Modified Stationary Source Review Rule

District Rule 2201 has been amended since this facility's initial Title V permit was issued. However the requirements of this rule are only triggered at the time the source undergoes a modification.

This project includes the conversion of Authorities to Construct N-645-5-4, '32-0, '-33-0, '-34-0, and '-35-0. Further discussion of these units is shown below:

ATC N-829-5-4

This ATC was for the modification of a 630,000 gallon internal floating roof tank to replace the existing seal with a new HMT minishoe primary seal and a Vaporflex secondary seal. Conditions #4, #5, and #48 of the ATC enforce the Rule 2201 requirements and have been included on the proposed Title V permit as conditions #1, #2, and #45.

ATC N-829-32-0

This ATC was for the installation of a 1,953,000 gallon welded internal floating roof tank to store gasoline, diesel, ethanol, and/or methanol. ATC conditions #2 and #3 specify Rule 2201 offsetting requirements. These conditions were satisfied and have been removed from the proposed Title V permit. Conditions #6, #7, #8, #9, and #10 of the ATC enforce the Rule 2201 requirements and have been included on the proposed Title V permit as conditions #1, #2, #3, #4, and #5.

ATC N-829-33-0

This ATC was for the installation of a 3,365,000 gallon welded internal floating roof tank to store gasoline, diesel, ethanol, and/or methanol. ATC conditions #2 and #3 specify Rule 2201 offsetting requirements. These conditions were satisfied and have been removed from the proposed Title V permit. Conditions #6, #7, #8, #9, and #10 of the ATC enforce the Rule 2201 requirements and have been included on the proposed Title V permit as conditions #3, #4, #5, #6, and #7.

N-829-34-0

This ATC was for the installation of a 1,953,000 gallon welded internal floating roof tank to store diesel only. This unit is technically exempt from District Rule 2201 requirements per Section 6.6.5 of Rule 2020; however, the applicant has asked for the permit to be issued for the unit. No further discussion of 2201 requirements is necessary for this unit.

N-829-35-0

This ATC was for the installation of a 1,260,000 gallon welded internal floating roof tank to store denatured ethanol. ATC conditions #42 and #43 specify Rule 2201 offsetting requirements. These conditions were satisfied and have been removed from the proposed Title V permit. Conditions #4, #5, #6, #7, #8, #9, #39, #40, and #41 of the ATC enforce the Rule 2201 requirements and have been included on the proposed Title V permit as conditions #1, #2, #3, #4, #5, #6, #36, #37, and #38.

District Rule 2410 – Prevention of Significant Deterioration

This source has never been subject to this rule; therefore there are no PSD permit applicable requirements to include in the Title V permit.

C. District Rule 2520 - Federally Mandated Operating Permits

No changes to this Rule have occurred since issuance of the previous TV permit; however, greenhouse gas emissions will be addressed under Rule 2520 during this renewal.

Greenhouse Gas Discussion

There are no federally applicable Greenhouse Gas (GHG) requirements for this source. It should be noted that the Mandatory Greenhouse Gas Reporting rule (40 CFR Part 98) is not included in the definition of an applicable requirement within Title V (per 40 CFR 71.2). Therefore, there will be no further discussion of GHG in this evaluation.

D. 40 CFR Part 82, Subpart B - <u>Servicing of Motor Vehicle Air</u> Conditioners

The requirements of this Subpart pertain to air conditioners, chillers and refrigerators located at a Title V source and to disposal of air conditioners or maintenance/recharging/disposal of motor vehicle air conditioners (MVAC).

Compliance with the requirements of this rule will be ensured with the listed permit conditions for the facility-wide permit in the table below:

E. 40 CFR Part 82, Subpart F - Recycling and Emission Reduction

The requirements of this subpart pertain to air conditioners, chillers and refrigerators located at a Title V source and to disposal of air conditioners or maintenance/recharging/disposal of motor vehicle air conditioners (MVAC).

Compliance with the requirements of this rule will be ensured with the listed permit conditions for the facility-wide permit in the table below:

G. 40 CFR Part 64-CAM

40 CFR Part 64 requires Compliance Assurance Monitoring (CAM) for units that meet the following three criteria:

- 1) the unit must have an emission limit for the pollutant;
- 2) the unit must have add-on controls for the pollutant; these are devices such as flue gas recirculation (FGR), baghouses, and catalytic oxidizers; and
- 3) the unit must have a pre-control potential to emit of greater than the major source thresholds.

a. N-829-1-7 and 2-7: North and South Truck Loading Racks

These permits are for the north and south truck loading racks. The truck loading racks are served by the vapor combustion system listed in PTO N-829-20-9. These units were previously determined to be subject to CAM and were evaluated in detail in the previous Title V renewal (District Project N-1092711 and CAM was determined at that time. The CAM requirements will continue to be included on PTO N-829-20-9 as conditions #11 and #12.

b. N-829-5-5, '-21-5, '-28-6, and '-29-7: Organic Liquid Storage Tanks

These permits do not contain emission limits. Therefore, CAM is not applicable to these units.

c. N-829-6-8, '-7-6, '-16-7, '-17-7, '-18-8, -22-5, and '-31-5: Organic Liquid Storage Tanks

These tanks were evaluated in the previous TV Renewal and were determined to not be equipped with any add-on control equipment; therefore, CAM requirements are not applicable to these units.

d. N-829-20-8: Vapor Combustion System

This permit is for the add-on control equipment. No emission units area associated with this permit. Thus CAM is not applicable.

e. N-829-32-0, '-33-0, -'34-0, and '-35-0; Organic Liquid Storage Tanks

These are internal floating roof tanks with no add-on control technology. It has been previously determined that the internal floating roofs are not add-on controls (TV Renewal for Project N-1092711). Thus, CAM is not applicable.

IX. PERMIT SHIELD

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit. - 10. The floating roof shall be floating on the surface of the stored liquid at all times (i.e., off the roof leg supports) except during the initial fill until the roof is lifted off the leg supports and when the tank is completely emptied and subsequently refilled. When the roof is resting on the leg supports the processes of filling or emptying and refilling the tank shall be continuous and shall be accomplished as rapidly as possible. Whenever the permittee intends to land the roof on its legs, the permittee shall notify the APCO in writing at least five calendar days prior to performing the work. The tank must be in compliance with this rule before it may land the roof on its legs. [District Rule 4623 Section 5.4.3, 40 CFR 60.112b(a)(1)(i)] Federally Enforceable Through Title V Permit
- 11. No gap between the tank shell and the primary seal shall exceed one and one-half (1-1/2) inches. [District Rule 4653 Sections 5.3.2.1.1 and 5.4.1] Federally Enforceable Through Title V Permit
- 12. The cumulative length of all gaps between the tank shell and the primary seal: 1) Greater than one-half (1/2) inch shall not exceed 10 percent of the circumference of the tank; and 2) Greater than one-eighth (1/8) inch shall not exceed 30 percent of the circumference of the tank. [District Rule 4623 Sections 5.3.2.1.1 and 5.4.1] Federally Enforceable Through Title V Permit
- 13. The primary seal shall have no continuous gap greater than one-eighth (1/8) inch shall exceed 10 percent of the tank circumference. [District Rule 4623 Sections 5.3.2.1.1 and 5.4.1] Federally Enforceable Through Title V Permit
- 14. No gap between the tank shell and the secondary seal shall exceed one-half (1/2) inch. [District Rule 4623 Sections 5.3.2.1.2 and 5.4.1] Federally Enforceable Through Title V Permit
- 15. The cumulative length of all gaps between the tank shell and the secondary seal, greater than one-eighth (1/8) inch shall not exceed 5 percent of the tank circumference. [District Rule 4623 Sections 5.3.2.1.2 and 5.4.1] Federally Enforceable Through Title V Permit
- 16. The metallic shoe-type seal shall be installed so that one end of the shoe extends into the stored liquid and the other end extends a minimum vertical distance of 18 inches above the stored liquid surface. [District Rule 4623 Section 5.4.1] Federally Enforceable Through Title V Permit
- 17. The geometry of the metallic-shoe type seal shall be such that the maximum gap between the shoe and the tank shell shall be no greater than 3 inches for a length of at least 18 inches in the vertical plane above the liquid. [District Rule 4623 Sections 5.3.2.1.4 and 5.4.1] Federally Enforceable Through Title V Permit
- 18. There shall be no holes, tears, or openings in the secondary seal or in the primary seal envelope that surrounds the annular vapor space enclosed by the roof edge, seal fabric, and secondary seal. [District Rule 4623 Sections 5.3.2.1.5 and 5.4.1] Federally Enforceable Through Title V Permit
- 19. The secondary seal shall allow easy insertion of probes of up to one and one-half (1-1/2) inches in width in order to measure gaps in the primary seal. [District Rule 4623 Sections 5.3.2.1.6 and 5.4.1] Federally Enforceable Through Title V Permit
- 20. The secondary seal shall extend from the roof to the tank shell and shall not be attached to the primary seal. [District Rule 4623 Sections 5.3.2.1.7 and 5.4.1] Federally Enforceable Through Title V Permit
- 21. All openings in the roof used for sampling and gauging shall provide a projection below the liquid surface to prevent belching of liquid and to prevent entrained or formed organic vapor from escaping from the liquid contents of the tank and shall be equipped with a cover, seal or lid. The cover seal or lid shall be in a closed position, with no visible gaps and be gas tight, except when the device or appurtenance is in use. [District Rule 4623 Section 5.5.1] Federally Enforceable Through Title V Permit
- 22. A gas-tight condition is defined as a condition without a gas leak. A gas leak is defined as a reading in excess of 10,000 ppmv, as methane, above background as measured by a portable hydrocarbon detection instrument in accordance with the procedures specified in EPA Test Method 21. A reading in excess of 10,000 ppmv above background is a violation of this permit and Rule 4623 and shall be reported as a deviation. [District Rule 4623 Sections 3.11, 5.1.3, and 6.4.8] Federally Enforceable Through Title V Permit
- 23. Each opening in a non-contact internal floating roof except for automatic bleeder vents (vacuum breaker vents) and rim space vents shall provide a projection below the liquid surface. [District Rule 4623 Section 5.5.2.1.1, 40 CFR 60.112b(a)(1)(iii)] Federally Enforceable Through Title V Permit

- 24. Each opening in the internal floating roof except for leg sleeves, automatic bleeder vents, rim space vents, column wells, ladder wells, sample wells, and stub drains shall be equipped with a cover, or a lid shall be maintained in a closed position at all times (i.e. no visible gaps) except when the device is in use. The cover or lid shall be equipped with a gasket. Covers on each access hatch and automatic gauge float well shall be bolted in place except when they are in use. [District Rule 4623 Section 5.5.2.1.2, 40 CFR 60.112b(a)(1)(iv)] Federally Enforceable Through Title V Permit
- 25. Automatic bleeder vents shall be equipped with a gasket and shall be closed at all times when the roof is floating except when the roof is being floated off or is being landed on the leg roof supports. [District Rule 4623 Section 5.5.2.1.3, 40 CFR 60.112b(a)(1)(v)] Federally Enforceable Through Title V Permit
- 26. Rim vents shall be equipped with a gasket and shall be set to open only when the internal floating roof is not floating or at the manufacturer's recommended setting. [District Rule 4623 Section 5.5.2.1.4, 40 CFR 60.112b(a)(1)(vi)] Federally Enforceable Through Title V Permit
- 27. Each penetration of the internal floating roof for the purpose of sampling shall be a sample well. The well shall have a slit fabric cover that covers at least 90 percent of the opening. The fabric cover must be impermeable, [District Rule 4623 Section 5.5.2.1.5, 40 CFR 60.112b(a)(1)(vii)] Federally Enforceable Through Title V Permit
- 28. Each penetration of the internal floating roof that allows for the passage of a column supporting the fixed roof shall have a flexible fabric sleeve seal or a gasketed sliding cover. The fabric sleeve must be impermeable. [District Rule 4623 Section 5.5.2.1.6, 40 CFR 60.112b(a)(1)(viii)] Federally Enforceable Through Title V Permit
- 29. Each penetration of the internal floating roof that allows for the passage of a ladder shall have a gasketed sliding cover. [40 CFR 60.112b(a)(1)(ix)] Federally Enforceable Through Title V Permit
- 30. All slotted sampling or gauging wells, and similar fixed projections through the floating roof shall provide a projection below the liquid surface. [District Rule 4623 Section 5.5.2.4.1] Federally Enforceable Through Title V Permit
- 31. The gap between the pole wiper and the slotted guidepole shall be added to the gaps measured to determine compliance with the secondary seal requirement, and in no case shall not exceed one-eighth (1/8) inch. [District Rule 4623 Section 5.5.2.4.3] Federally Enforceable Through Title V Permit
- 32. The permittee shall visually inspect the internal floating roof and its appurtenant parts, fittings, etc., and measure the gaps of the primary seal and/or secondary seal prior to filling the tank. If there are holes, tears, or other openings in the primary seal, the secondary seal, or the seal fabric or defects in the internal floating roof or its appurtenant parts, components, fittings, etc., the operator shall repair the defects before filling the tank. [District Rule 4623 Section 6.1.4.1, 40 CFR 60.113b(a)(1)] Federally Enforceable Through Title V Permit
- 33. The permittee shall visually inspect, through the manholes, roof hatches, or other opening on the fixed roof, the internal floating roof and its appurtenant parts, fittings, etc., and the primary seal and/or secondary seal at least once every 12 months after the tank is initially filled with an organic liquid. There should be no visible organic liquid on the roof, tank walls, or anywhere. Other than the gap criteria specified by this rule, no holes, tears, or other openings are allowed that would permit the escape of vapors. Any defects found are violations of this rule. [District Rule 4623 Section 6.1.4.2, 40 CFR 60.113b(a)(2)] Federally Enforceable Through Title V Permit
- 34. If any failure (i.e. visible organic liquid on the internal floating roof, tank walls or anywhere, holes or tears in the seal fabric) is detected during 12 month visual inspection, the permittee shall repair the items or empty and remove the storage vessel from service within 45 days. If the detected failure cannot be repaired within 45 days and if the vessel cannot be emptied within 45 days, a 30-day extension may be requested from the APCO in the inspection report. Such a request must document that alternate storage capacity is unavailable and specify a schedule of actions the company will take that will assure theat the control equipment will be repaired or the vessel will be emptied as soon as possible. [40 CFR 60.113b(a)(2)] Federally Enforceable Through Title V Permit
- 35. The permittee shall conduct actual gap measurements of the primary seal and/or secondary seal at least once every 60 months. Other than the gap criteria specified by this permit, no holes, tears, or other openings are allowed that would permit the escape of hydrocarbon vapors. Any defects found shall constitute a violation of this rule. [District Rule 4623 Section 6.1.4.3] Federally Enforceable Through Title V Permit

- 36. The permittee shall submit the reports of the floating roof tank inspections to the APCO within five calendar days after the completion of the inspection only for those tanks that failed to meet the applicable requirements of Rule 4623, Sections 5.2 through 5.5. The inspection report for tanks that that have been determined to be in compliance with the requirements of Sections 5.2 through 5.5 need not be submitted to the APCO, but the inspection report shall be kept on-site and made available upon request by the APCO. The inspection report shall contain all necessary information to demonstrate compliance with the provisions of this rule, including the following: 1) Date of inspection and names and titles of company personnel doing the inspection. 2) Tank identification number and Permit to Operate number. 3) Measurements of the gaps between the tank shell and primary and secondary seals. 4) Gas-tight status of the tank and floating roof deck fittings. Records of the gas-tight status shall include the vapor concentration values measured in parts per million by volume (ppmv). 5) Data, supported by calculations, demonstrating compliance with the requirements specified in Sections 5.3.1.3 and 5.5.2.4.3 of Rule 4623. 6) Any corrective actions or repairs performed on the tank in order to comply with rule 4623 and the date(s) such actions were taken. [District Rule 4623 Section 6.3.5] Federally Enforceable Through Title V Permit
- 37. Permittee shall maintain the records of the internal floating roof landing activities that are performed pursuant to Rule 4623, Sections 5.3.1.3 and 5.4.3. The records shall include storage temperature, type of organic liquid stored in the tank, the purpose of landing the roof on its legs, the date of roof landing, duration the roof was on its legs, the level or height at which the tank roof was set to land on its legs, and the lowest liquid level in the tank. [District Rule 4623 Section 6.3.7] Federally Enforceable Through Title V Permit
- 38. The permittee shall notify the District in writing at least 30 days prior to conduct the visual inspection of the storage vessel, so the District can arrange an observer. [40 CFR 60.113b(a)(5)] Federally Enforceable Through Title V Permit
- 39. The permittee shall maintain records of daily, monthly, cumulative annual organic liquid throughput in gallons. The cumulative annual records shall be updated weekly. [District Rule 2201] Federally Enforceable Through Title V Permit
- 40. The permittee shall maintain records of TVP tests and the temperature of the organic liquid stored in the tank. [District Rule 2201] Federally Enforceable Through Title V Permit
- 41. The permittee shall keep all records on-site for a period of at least five years. These records shall be made available for District inspection upon request, [District Rules 2201 and 4623] Federally Enforceable Through Title V Permit
- 42. Prior to operating under this Authority to Construct permit, the permittee shall offset the following quantities of VOC: 1st quarter 438 lb, 2nd quarter 438 lb, 3rd quarter 438 lb, and 4th quarter 438 lb. Offsets shall be provided at the applicable offset ratio specified in Table 4-2 of Rule 2201 (as amended 9/21/06). [District Rule 2201]
- 43. ERC Certificate Number S-3299-1 (or a certificate split from this certificate) shall be used to supply the required VOC offsets, unless a revised offsetting proposal is received and approved by the District. Following the revisions, this Authority to Construct permit shall be reissued, administratively specifying the new offsetting proposal. Original public noticing requirements, if any, shall be duplicated prior to re-issuance of this Authority to Construct permit. [District Rule 2201]
