### I. PROPOSAL

Bakersfield City Wastewater Plant #3 was issued a Title V Operating Permit on September 30, 2012. As required by District Rule 2520, the applicant is requesting a permit renewal. The existing Title V permit shall be reviewed and modified to reflect all applicable District and federal rules updated, removed, or added since the issuance of the initial Title V Operating Permit.

The purpose of this evaluation is to provide the legal and factual basis for all updated applicable requirements and to determine if the facility will comply with these updated requirements. It also specifically identifies all additions, deletions, and/or changes made to permit conditions or equipment descriptions.

### II. FACILITY LOCATION

Bakersfield City Wastewater Plant #3, facility S-3103 is located at 6901 McCutchen Road in Bakersfield, CA.

### III. EQUIPMENT LISTING

A detailed facility printout listing all permitted equipment at the facility is included as Attachment C.

### IV. GENERAL PERMIT TEMPLATE USAGE

The applicant does not propose to use any general permit templates. However, the Umbrella Permit UM-03 is currently in use and will be retained as the facility-wide conditions to ensure compliance.

### V. SCOPE OF EPA AND PUBLIC REVIEW

Since the applicant is not requesting any model general permit templates, all federally enforceable conditions in this current Title V permit will be subject to EPA and public review.

### VII. REQUIREMENTS NOT FEDERALLY ENFORCEABLE

For each Title V source, the District issues a single permit that contains the Federally Enforceable requirements, as well as the District-only requirements. The District-only requirements are not a part of the Title V Operating Permits. The terms and conditions that are part of the facility's Title V permit are designated as "Federally Enforceable Through Title V Permit".

For this facility, the following are not federally enforceable and will not be discussed beyond this section.

District Rule 4102, Nuisance (adopted May 21, 1992, amended December 17, 1992)

Condition 1 on the facility-wide permit identifies the requirements of Rule 4102.

### VIII. PERMIT REQUIREMENTS

The purpose of this evaluation is to review changes to federally enforceable requirements. Therefore, this compliance section will address rules that have been amended or added since the issuance of the last Title V permit renewal. In addition, several of the permits for this facility have been revised to reflect the most recent and complete conditions set forth in District Rules. Some of the equipment descriptions have been revised to reflect current District equipment description standards. This change is administrative in nature and only serves to clarify the permitted equipment. The revised equipment descriptions are listed on each individual permit.

### **District Rules**

### A. District Rule 2020, Exemptions

Rule 2020 has been amended.

This rule identifies emissions units that are not required to obtain an Authority to Construct or Permit to Operate. This rule also specifies the recordkeeping requirements to verify the exemption and outlines the compliance schedule for emissions units that lose the exemption after installation.

Condition 5 on the facility-wide permit identifies the requirements of Rule 2020.

### B. District Rule 2201, New and Modified Stationary Source Review Rule

District Rule 2201 has been amended since this facility's initial Title V permit was issued. However, the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any NSR permit actions have already been incorporated into the current Title V permit.

### C. District Rule 2410, Prevention of Significant Deterioration

District Rule 2410 has been newly adopted since this facility's initial Title V permit was issued. However, the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any PSD permit actions have already been incorporated into the current Title V permit.

### D. District Rule 4702, Internal Combustion Engines

The purpose of this rule is to limit the emissions of nitrogen oxides (N0x), carbon monoxide (CO), and volatile organic compounds (VOC) from internal combustion engines. This rule applies to any internal combustion (IC) engine with a rated brake horsepower of 25 or greater.

The rule was amended in November 14, 2013.

The following permit requirements ensure compliance with the amended rule:

  - Conditions 5, 8 through 12, and 14 on the proposed permit comply with this rule.
- S-3103-19-5: 1,175 BHP JENBACHER MODEL JMS316 DIGESTER GAS-FIRED IC ENGINE COGENERATION SYSTEM WITH TURBOCHARGER AND AIR TO FUEL RATIO CONTROLLER AND SULFATREAT FUEL GAS DRY SULFUR SCRUBBING SYSTEM SHARED WITH UNITS S-3103-13, '-14, '-15, '-16, '-17, '-18, '-20, AND '-28
  - Conditions 4, 6, 8, 10 through 17, 20, 21, and 29 on the proposed permit comply with this rule.
- 3. S-3103-20-5: 1,175 BHP JENBACHER MODEL JMS316 DIGESTER GAS-FIRED IC ENGINE COGENERATION SYSTEM WITH TURBOCHARGER AND AIR TO FUEL RATIO CONTROLLER AND SULFATREAT FUEL GAS DRY SULFUR SCRUBBING SYSTEM SHARED WITH UNITS S-3103-13, '-14, '-15, '-16, '-17, '-18, '-20, AND '-28
- Conditions 4, 6, 8, 10 through 17, 20, 21, and 23 on the proposed permit comply with this rule.
- 4. S-3103-22-2: 2,937 BHP CATERPILLAR MODEL 3516C TA TIER 2 CERTIFIED DIESEL FIRED EMERGENCY STANDBY IC ENGINE POWERING AN ELECTRICAL GENERATOR (AERATION BLOWER 1)
  - Conditions 2, 4, 5, 6, and 11 through 14 on the proposed permit comply with this rule.

- 5. S-3103-23-2: 2,937 BHP CATERPILLAR MODEL 3516C TA TIER 2 CERTIFIED DIESEL FIRED EMERGENCY STANDBY IC ENGINE POWERING AN ELECTRICAL GENERATOR (AERATION BLOWER 2)
  - Conditions 2, 4, 5, 6, and 11 through 14 on the proposed permit comply with this rule.
- 6. S-3103-24-2: 2,206 BHP CATERPILLAR MODEL 3512C TIER 2 CERTIFIED DIESEL FIRED IC ENGINE WITH TURBOCHARGER AND AFTER COOLER POWERING AN EMERGENCY GENERATOR (AERATION BASIN 3)
  - Conditions 2, 4, 5, 6, and 11 through 14 on the proposed permit comply with this rule.
- 7. S-3103-25-2: 1,502 BHP CATERPILLAR MODEL C32 TIER 2 CERTIFIED DIESEL FIRED IC ENGINE WITH TURBOCHARGER AND AFTER COOLER POWERING AN EMERGENCY GENERATOR (HEAD WORKS)
  - Conditions 2, 4, 5, 6, and 11 through 14 on the proposed permit comply with this rule.

### Federal Requirements

### A. 40 CFR Part 64, Compliance Assurance Monitoring (CAM)

To be subject to CAM for a particular pollutant, an emissions unit must meet <u>all</u> of the following criteria:

- The unit must have an emission limit for the pollutant,
- The unit must have add-on controls for the pollutant, and
- The pre-control potential to emit for the unit must exceed major source thresholds.

CAM is not triggered for any permit units. None of the units are equipped with add on control equipment and none of the units have uncontrolled emissions limits that exceed major source thresholds.

# B. 40 CFR 60 Subpart IIII – Standards of Performance for Stationary Compression Ignition Internal Combustion Engines

Recent amendments concerning manufacturers of compression ignition engines do not effect the emergency compression ignition engines at this facility. No other amendments affect the existing compression ignited IC engines. Continued compliance is expected.

# C. 40 CFR Part 60, Subpart JJJJ, Standards of Performance for Spark Ignition Internal Combustion Engines

Recent amendments concerning manufacturers of compression ignition engines do not effect the emergency compression ignition engines at this facility. No other amendments affect the existing compression ignited IC engines. Continued compliance is expected.

# D. 40 CFR Part 63, Subpart ZZZZ, National Emissions Standards for Hazardous Air Pollutants (NESHAPS) for Stationary Reciprocating Internal Combustion Engines

Only the existing 1,199 bhp compression ignition emergency generator S-3103-10 is subject to this subpart. No other amendments affect the existing compression ignited IC engine. Continued compliance is expected.

### IX. PERMIT SHIELD

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit. Compliance with the terms and conditions of the Operating Permit is considered compliance with all applicable requirements upon which those conditions are based, including those that have been subsumed.

### A. Requirements Addressed by Model General Permit Templates

No general templates have been proposed. However, facility-wide conditions from umbrella permit UM-03 have been used. These contain standard permit shields.

### B. Requirements not Addressed by Model General Permit Templates

No extra permit shields have been proposed or utilized for any of the existing permits.

### C. Obsolete Permit Shields From Existing Permit Requirements

There are no obsolete permit shields on the permit.

# **FACILITY-WIDE REQUIREMENTS**

- No air contaminant shall be released into the atmosphere which causes a public nuisance. [District Rule 4102] 1.
- The owner or operator shall notify the District of any breakdown condition as soon as reasonably possible, but no later 2. than one hour after its detection, unless the owner or operator demonstrates to the District's satisfaction that the longer reporting period was necessary. [District Rule 1100; County Rules 110 (Fresno, Stanislaus, San Joaquin); 109 (Merced); 113 (Madera); and 111 (Kern, Tulare, Kings)] Federally Enforceable Through Title V Permit
- The District shall be notified in writing within ten days following the correction of any breakdown condition. The breakdown notification shall include a description of the equipment malfunction or failure, the date and cause of the initial failure, the estimated emissions in excess of those allowed, and the methods utilized to restore normal operations, [District Rule 1100; County Rules 110 (Fresno, Stanislaus, San Joaquin); 109 (Merced); 113 (Madera); and 111 (Kern, Tulare, Kings)] Federally Enforceable Through Title V Permit
- The owner or operator of any stationary source operation that emits more than 25 tons per year of nitrogen oxides or reactive organic compounds, shall provide the District annually with a written statement in such form and at such time as the District prescribes, showing actual emissions of nitrogen oxides and reactive organic compounds from that source. [District Rule 1160] Federally Enforceable Through Title V Permit
- Any person building, altering or replacing any operation, article, machine, equipment, or other contrivance, the use of which may cause the issuance of air contaminants or the use of which may eliminate, reduce, or control the issuance of air contaminants, shall first obtain an Authority to Construct (ATC) from the District unless exempted by District Rule 2020 (12/20/07), [District Rules 2010 and 2020] Federally Enforceable Through Title V Permit
- The permittee must comply with all conditions of the permit including permit revisions originated by the District. All terms and conditions of a permit that are required pursuant to the Clean Air Act (CAA), including provisions to limit potential to emit, are enforceable by the EPA and Citizens under the CAA. Any permit noncompliance constitutes a violation of the CAA and the District Rules and Regulations, and is grounds for enforcement action, for permit termination, revocation, reopening and reissuance, or modification; or for denial of a permit renewal application. [District Rules 2070; 2080; and 2520] Federally Enforceable Through Title V Permit
- A Permit to Operate or an Authority to Construct shall not be transferred unless a new application is filed with and approved by the District. [District Rule 2031] Federally Enforceable Through Title V Permit
- Every application for a permit required under Rule 2010 (12/17/92) shall be filed in a manner and form prescribed by the District. [District Rule 2040] Federally Enforceable Through Title V Permit
- The operator shall maintain records of required monitoring that include: 1) the date, place, and time of sampling or measurement; 2) the date(s) analyses were performed; 3) the company or entity that performed the analysis; 4) the analytical techniques or methods used; 5) the results of such analysis; and 6) the operating conditions at the time of sampling or measurement. [District Rule 2520] Federally Enforceable Through Title V Permit
- 10. The operator shall retain records of all required monitoring data and support information for a period of at least 5 years from the date of the monitoring sample, measurement, or report. Support information includes copies of all reports required by the permit and, for continuous monitoring instrumentation, all calibration and maintenance records and all original strip-chart recordings. [District Rule 2520] Rederally Enforceable Through Title V Permit

- 11. The operator shall submit reports of any required monitoring at least every six months unless a different frequency is required by an applicable requirement. All instances of deviations from permit requirements must be clearly identified in such reports. [District Rule 2520] Federally Enforceable Through Title V Permit
- 12. Deviations from permit conditions must be promptly reported, including deviations attributable to upset conditions, as defined in the permit. For the purpose of this condition, promptly means as soon as reasonably possible, but no later than 10 days after detection. The report shall include the probable cause of such deviations, and any corrective actions or preventive measures taken. All required reports must be certified by a responsible official consistent with District Rule 2520 (6/21/01). [District Rules 2520 and 1100] Federally Enforceable Through Title V Permit
- 13. If for any reason a permit requirement or condition is being challenged for its constitutionality or validity by a court of competent jurisdiction, the outcome of such challenge shall not affect or invalidate the remainder of the conditions or requirements in that permit. [District Rule 2520] Federally Enforceable Through Title V Permit
- 14. It shall not be a defense for a permittee in an enforcement action that it would have been necessary to halt or reduce the permitted activity in order to maintain compliance with the conditions of the permit. [District Rule 2520] Federally Enforceable Through Title V Permit
- 15. The permit may be modified, revoked, reopened and reissued, or terminated for cause. The filing of a request by the permittee for a permit modification, revocation and reissuance, or termination, or a notification of planned changes or anticipated noncompliance does not stay any permit condition. [District Rule 2520] Federally Enforceable Through Title V Permit
- 16. The permit does not convey any property rights of any sort, or any exclusive privilege. [District Rule 2520] Federally Enforceable Through Title V Permit
- 17. The Permittee shall furnish to the District, within a reasonable time, any information that the District may request in writing to determine whether cause exists for modifying, revoking and reissuing, or terminating the permit or to determine compliance with the permit. Upon request, the permittee shall also furnish to the District copies of records required to be kept by the permit or, for information claimed to be confidential, the permittee may furnish such records directly to EPA along with a claim of confidentiality. [District Rule 2520] Federally Enforceable Through Title V
- 18. The permittee shall pay annual permit fees and other applicable fees as prescribed in Regulation III of the District Rules and Regulations. [District Rule 2520] Federally Enforceable Through Title V Permit
- 19. Upon presentation of appropriate credentials, a permittee shall allow an authorized representative of the District to enter the permittee's premises where a permitted source is located or emissions related activity is conducted, or where records must be kept under condition of the permit. - 20. Upon presentation of appropriate credentials, a permittee shall allow an authorized representative of the District to have access to and copy, at reasonable times, any records that must be kept under the conditions of the permit. Upon presentation of appropriate credentials, a permittee shall allow an authorized representative of the District to inspect at reasonable times any facilities, equipment, practices, or operations regulated or required under the permit. Upon presentation of appropriate credentials, a permittee shall allow an authorized representative of the District to sample or monitor, at reasonable times, substances or parameters for the purpose of assuring compliance with the permit or applicable requirements.
