Dear Mr. Allen:

The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to Broadview Coop Gin for emission reductions generated by the shutdown of a cotton gin, at 40109 W Bullard Ave, Firebaugh, CA. The quantity of ERCs to be issued is 484 lb-NOx/yr, 52 lb-SOx/yr, 16,009 lb-PM10/yr, 67 lb-CO/yr, 18 lb-VOC/yr and 222 metric tons CO2e/yr.

Enclosed are copies of the ERC Certificates and a copy of the notice of final action to be published approximately three days from the date of this letter.

Notice of the District's preliminary decision to issue the ERC Certificates was published on May 30, 2017. The District's analysis of the proposal was also sent to CARB and US EPA Region IX on May 25, 2017. No comments were received following the District's preliminary decision on this project.

Also enclosed is an invoice for the engineering evaluation fees pursuant to District Rule 3010. Please remit the amount owed, along with a copy of the attached invoice, within 60 days.
