The Air Pollution Control Officer has issued the Authority to Construct permits to City of Lathrop for the installation of two diesel-fired emergency engines, at 950 Steward Road, Lathrop. Notice of the District's preliminary decision to issue the Authority to Construct permits was published on September 14, 2018. - Only CARB certified diesel fuel containing not more than 0.0015% sulfur by weight is to be used. [District Rules 2201 and 4801, and 17 CCR 93115]
- Emissions from this IC engine shall not exceed any of the following limits: 3.80 g-NOx/bhp-hr, 0.50 g-CO/bhp-hr, or 0.20 g-VOC/bhp-hr. [District Rule 2201 and 17 CCR 93115]
- Emissions from this IC engine shall not exceed 0.14 g-PM10/bhp-hr based on USEPA certification using ISO 8178 test procedure. [District Rules 2201 and 4102, and 17 CCR 93115]
