- Contractor will notify the District in advance of all sub-contractors that will be used on this job.
 The District reserves the right to accept or reject any of the sub-contracting firms. All subcontractors must meet the same licensing and insurance requirements as listed above. The
 Contractor will assume full responsibility for the performance and quality of work of any subcontractor it hires for this job.
- Work is to be performed according to the attached plans and specifications. It is recommended
 that references from similar jobs be supplied with this quotation. All work done must be to the
 satisfaction of the District, the FAA, the City of Tracy, the County of San Joaquin, the State of
 California, Pacific Gas and Electric, and Pacific Bell. Submission of a quotation indicates
 contractor has thoroughly examined this document, plus all attached plans and specifications,
 and agrees to provide materials and labor needed to satisfy them.

- Contractor is responsible for the <u>timely</u> coordination of permit inspections and other activities required by the Utilities and the City of Tracy. Should the contractor have difficulty in getting a prompt response from the Utilities or the City, the contact person below should be immediately called for assistance. Delays caused by the failure of the contractor to arrange these activities in a timely manner will not be excused. However, reasonable delays due to weather will be allowed if coordinated with the contact person. While the District took considerable effort to inform and obtain clearances in advance from the City and Utilities for this job, unforeseen circumstances may arise that would result in some delay.
