

PUBLIC NOTICE OF AVAILABILITY PROPOSED NEGATIVE DECLARATION

May 7, 2004

Project Title: Amendment of Regulation VIII (Fugitive PM 10 Prohibitions)

Project Location: All land within the boundaries of the San Joaquin Valley Unified Air Pollution Control District, including the entire counties and all the cities of Fresno, Kings, Madera, Merced, Tulare, San Joaquin, Stanislaus, and the San Joaquin Valley portion of Kern County

Description of Project:

The San Joaquin Valley Air Basin (SJVAB) does not meet the federal health-based National Ambient Air Quality Standards (NAAQS) for particulate matter with an aerodynamic diameter of 10 microns or less (PM10). Specifically, the SJVAB is classified as a "serious" PM10 nonattainment area, the most severe PM10 classification. The Federal Clean Air Act (FCAA) requires the San Joaquin Valley Unified Air Pollution Control District (SJVUAPCD) and other serious PM10 areas to implement Best Available Control Measures (BACM) to control fugitive PM10 emissions.

Regulation VIII applies only to fugitive dust sources. Regulation VIII applies to primary PM10 sources that include construction, demolition, excavation, extraction, handling and storage of bulk materials, landfills, unpaved roads, and vehicle/equipment parking, shipping, receiving, transfer, and service areas. The proposed amendments to Regulation VIII are necessary to address the deficiencies identified by United States Environmental Protection Agency (EPA) and to upgrade existing Reasonably Available Control Measures (RACM) level rules to meet the more stringent BACM level.

In general, the proposed amendments to Regulation VIII would provide broader applicability, reduce certain thresholds, remove certain exemptions, and includes updated tables that clarify dust control requirements and options. District staff estimates implementation of the proposed amendments to Regulation VIII to reduce cumulative emissions by approximately 18.8 tons per day for all categories of fugitive emissions.
