**NOTICE OF PUBLIC MEETING  
OF THE CLIMATE CHANGE ACTION PLAN  
TECHNICAL WORKGROUPS**

NOTICE IS HEREBY GIVEN that the Climate Change Action Plan Technical Workgroups will meet to explore possible options for addressing greenhouse gas (GHG) emissions during the CEQA process and development of the San Joaquin Valley Carbon Exchange Program.

The SJVAPCD has established two technical workgroups to develop recommendations and guide the District in the development of a Climate Change Action Plan. The workgroups contain representatives from local governmental planning agencies, industry, environmental organizations, the general public, and District staff. Based on the results of the workgroups' discussions, SJVAPCD staff will prepare recommendations to be presented to the APCO. Staff will then present recommendations to the Governing Board for consideration in the summer of 2009.

**Greenhouse Gas Emissions/CEQA Guidance Technical Workgroup**

This technical workgroup will develop recommendations on addressing GHG emissions during the CEQA process. This workgroup will consider the following:

- Identification and quantification of GHG emissions,
- Determination of significance, and
- Mitigation of GHG impacts.

**San Joaquin Valley Carbon Exchange Program Technical Workgroup**

This technical workgroup will develop recommendations on the possible implementation of a greenhouse gas emissions banking program. This workgroup will consider the following:

- Banking requirements
- Compatibility with other GHG exchange programs,
- Possible uses of banked GHG emission reductions, and
- GHG emission reductions banking protocols.

At the February 4, 2009 SJVCE Technical Workgroup meeting District staff indicated that no additional meetings of this workgroup would be needed. However, upon further consideration, one additional meeting of this workgroup will be held to present to the workgroup the final report to the APCO regarding the development of the SJVCE and to describe the next steps that the District will take.
