**And**

**Approve Proposed Amendments to Rule 2301 (Emission Reduction Credit Banking)**

NOTICE IS FURTHER GIVEN that, pursuant to CH&SC Section 40727.2 (g) a rule consistency analysis of the draft amendments to Rule 2301 is not required. The draft Rule 2301 amendments do not strengthen emission limits or impose more stringent monitoring, reporting, or recordkeeping requirements. Additionally, the proposed District Policy: Addressing GHG Emission Impacts for Stationary Source Projects Under CEQA is not a proposed rule, therefore a rule consistency analysis is not required.
