NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a public hearing will be held on November 14, 2013 at 9:00 AM, or as soon thereafter as may be heard, at 1990 East Gettysburg Ave., Fresno, California. The following actions will be considered at the hearing:

Adopt proposed amendments to the following rules:

**Rule 4308 (Boilers, Steam Generators, and Process Heaters – 0.075 MMBtu/hr to less than 2.0 MMBtu/hr), and
Rule 4702 (Internal Combustion Engines)**

Proposed amendments to Rule 4308 would lower the NO_x emission limit for 0.075-0.4 MMBtu/hr sized instantaneous water heaters to 20 ppmv, and clarify existing rule requirements.

Proposed amendments to Rule 4702 would clarify rule applicability and clarify the existing NO_x emission limit for lean-burn waste gas fired engines used in non-agricultural operations. Proposed amendments would not change existing emissions limits or rule applicability.

These actions will affect sources in the counties of Fresno, Kern, Kings, Madera, Merced, San Joaquin, Stanislaus, and Tulare. The public hearing may also be attended through video teleconferencing at the San Joaquin Valley Unified Air Pollution Control District's (District) regional offices at 34946 Flyover Court, Bakersfield, California and at 4800 Enterprise Way, Modesto, California. NOTICE IS FURTHER GIVEN that the adopted rules will be submitted through the California Air Resources Board to the United States Environmental Protection Agency for incorporation as part of the California State Implementation Plan (SIP). The proposed actions would constitute a SIP revision.

NOTICE IS FURTHER GIVEN that pursuant to California Health and Safety Code Section 40727.2, the District has prepared a rule consistency analysis for proposed Rule 4308 that compare the elements of the proposed rule with the corresponding elements of other District and federal regulations and guidelines that apply to the same types of equipment or source categories, as applicable.
