NOTICE IS HEREBY GIVEN that public workshops will be held to present, discuss, and receive comments on the

Draft Extreme Ozone Attainment Demonstration Plan (OADP)

The *Draft Extreme OADP* is designed to meet the requirements of the federal Clean Air Act and contains measures needed to demonstrate attainment of the federal one-hour ozone National Ambient Air Quality Standards by November 15, 2010. Once approved by U.S. Environmental Protection Agency, the *Draft Extreme OADP* will become part of the State Implementation Plan for the San Joaquin Valley. The *Draft Extreme OADP* is also designed to meet the requirements of the California Clean Air Act and contains a *Triennial Progress Report* and a *Triennial Revision* to the District's *Air Quality Attainment Plan* that address progress towards attaining California's one-hour ambient air quality standard for ozone.
