- 3. <u>APPROVE MINUTES OF DECEMBER 4, 2007</u>—The Minutes for December 4, 2007 were approved as submitted.
- 4. <u>Public Comments</u>—There were no public comments.
- 5. <u>ELECTION OF CHAIR</u>—Due to the lack of a quorum in each interest group, this item was tabled to the next meeting.
- 6. Chair Comments—There were no comments from the Chair.
- 7. EXECUTIVE DIRECTOR/APCO COMMENTS—Rick McVaigh, Deputy APCO presented the report. He noted the Governing Board's new Chair is San Joaquin County Supervisor Leroy Ornellas, and the new Vice Chair is City of Ceres Councilmember Chris Vierra. He added that Supervisor Raymond Watson is the new Kern County representative. Mr. McVaigh stated that SB719, which was passed in 2007, changes the make-up of the Governing Board. The Governing Board will have one representative from the Board of Supervisors in each of the eight counties, three members from cities whose populations are less than 100,000; two members from cities whose populations are greater than 100,000; and two Governor appointees to include one physician and one scientist both of whom specialize in air quality related issues. He added that alternates are no longer allowed on the Board, and that each member must reside within the District.

Mr. McVaigh noted the Environmental Justice Advisory Group (EJAG) applications are due on January 14, 2008. Kevin Hamilton stated the EJAG application posted online was too detailed and complex. Toni Taber, Clerk to the Boards, distributed copies of the application as found on the web site. Mr. Hamilton noted that this was not the application he looked at previously, and perhaps he viewed a different application. Mr. McVaigh stated the District would take a look at the website and make sure it's clear.

Mr. McVaigh noted that of the Proposition 1B funds slated for goods movement, ARB is proposing to give the District 25% of the \$1 billion to share with Sacramento AQMD. The District was hoping to receive 36-46%. The District is asking Valley Legislators to support the District in its request for a higher percentage, and hopes the Valley will make a strong showing at the ARB meeting on January 24, 2008 (NOTE: this has now been delayed to February 28 & 29). Mr. McVaigh stated regulations alone will not get the Valley into attainment, so the District needs the incentive funds. Mr. McVaigh stated the District feels the severity of Air Quality issues should be the prime consideration in disbursement of the funds. He also stated that the topographical and meteorological challenges the District faces should also be considered. He used an example that a ton of emissions in the Valley stays in the Valley, whereas a ton of emissions in Los Angeles or the Bay Area gets disbursed by ocean breezes. He added ARB used an unofficial lower truck inventory that is not used in the State Implementation Plan. He stated the Board item coming up on January 17, 2008 would detail the District's view on this funding.

Manuel Cunha stated the Interest Groups should organize the current and past CAC members to attend the Governing Board meeting on January 17, 2008 to show support, and also attend the January 24, 2008 ARB meeting.

The Chair agreed with Mr. Cunha that the Valley needs to work together. Mr. Hamilton agreed and stated the original deal was crafted to give the District alone 30%, but ARB dropped it 5% and added the component to share funds with Sacramento. Mr. Hamilton suggested those who attend the ARB workshop should arrive with a list of programs the District could fund with the money. Mr. Cunha asked Mr. McVaigh to provide the list of items Mr. Hamilton requested. Mr. McVaigh asked Ms. DeSantiago to note it as an action item.

- 8. <u>UPDATE: FAST TRACK TO ATTAINMENT</u>—Mr. McVaigh stated the last Fast Track meeting was on December 11, 2007. ARB has assigned a staff member to the Fast Track Team. He noted there was a presentation on transit oriented development in the Central Valley, and another on Short Sea Shipping. He noted on January 28, 2008, there would be a conference on Short Sea Shipping. He stated the Community Clean Air Fund was discussed again as well as accelerating fleet turnover. Green Contracting and Inland Ports were also discussed as well as Healthy Air Living. The next meeting is scheduled for January 15, 2008.
- 9. <u>UPDATE: PROPOSED PM2.5 PLAN</u>—Don Hunsaker, Supervising Air Quality Planner, presented the report. He noted there were two workshops held in December. He stated the comment period closes on January 9, 2008. Another workshop is scheduled for February. The District is waiting on modeling from

ARB to complete some sections. He noted the plan is due to ARB in April, and they have scheduled to hear the Plan in June.

Kevin Hamilton asked how much of the Plan is completed. Mr. Hunsaker replied that the regional modeling is such an important component, he can't give a percentage, but the items out there are ready for serious review. He stated the contingency plan will be in the next version. Mary-Michal Rawling asked what the District's consequences will be if it's late to EPA. Mr. Hunsaker stated there is no transportation conformity issues linked to this Plan as there was for the Ozone Plan, but the District could face legal action.

- 10. <u>RULES UNDER DEVELOPMENT</u> George Heinen, Supervising Air Quality Engineer, presented the report.
- 11. Public Education Report Jaime Holt, Chief Communications Officer, presented the report. She stated on February 4, the District will partner with Operation Clean Air on a fireplace replacement program. This year, the grant allows upgrades to natural gas or propane only. A total of \$108,000 will be available this year, and the District hopes to give it all out. She noted the Healthy Air Living Summit will be from March 25-27, 2008, and will be held on each of the District's regional Cities (Bakersfield, Fresno and Modesto).

Mary-Michal Rawling asked if there were Hmong language calendars this year. Ms. Holt replied that there were, but all have been given out. Ms. Rawling asked what the cost of the fireplace upgrade is. Ms. Holt stated they are \$1500-\$2000.

Sarah Sharpe asked for a master calendar to be posted on the web.

12. <u>ARB COMMENTS</u> – Jeff Lindberg, ARB, presented the report. He noted there are workshops scheduled in Fresno on January 9<sup>-</sup> 2008, and in Sacramento on January 24, 2008. He stated the On Road Heavy Duty Truck issue would be heard on January 30, 2008 at Fresno City Hall.

Craig Duehring, ARB, presented a report on the Hydrogen Highway. He noted there are eight networked stations, and the rest are private stations. The Vision is 250 stations and 20,000 vehicles. He stated the program would roll out to Sacramento, the Bay Area and Los Angeles area first. Manuel Cunha noted the San Joaquin Valley should not be forgotten.

13. CAC Member Comments and CAC Suggestions to be included in the PRESENTATION OF THE CAC REPORT DURING THE GOVERNING BOARD MEETING ON THURSDAY, JANUARY 17, 2008—L. Denton Hoeh noted that he joined the CAC in 1992 and served as chair in 1996-1997. Due to a change in his occupation, he will no longer serve the Environmental Interest Group of the CAC, and this would be his last meeting.

Manuel Cunha questioned the protocol of having alternate board members sit at the dais with the primary board members. Suzanne Noble stated that their practice in the Southern Region is to have the Primary member at the table and the alternate sits in the audience and participates during Public Comment period. David Harrald noted that his alternate has always sat next to him and participated in the meeting. Sarah Sharpe stated if there is room at the dais, the alternates can sit there. Mr. McVaigh stated staff would follow up on this issue and return with it to the next Board Meeting.

#### **RULES AND PLANS ADOPTED IN JANUARY 2008**

Regulation III (Fees): Rule 3010 (Permit Fee); Rule 3020 (Permit Fee Schedules); Rule 3030 (Hearing Board Fees); Rule 3040 (Open Burning Fees; Rule 3050 (Asbestos Removal Fees); Rule 3060 (Emission Reduction Credit Banking Fee); Rule 3070 (Other Charges); Rule 3080 (Atmospheric Acidity Protection Act Program Fee); Rule 3090 (California Clean Air Act Fees); Rule 3110 (Air Toxics Fees); Rule 3120 (Regulation VIII Alternative Compliance Plan Review Fee); Rule 3135 (Dust Control Plan Fee); Rule 3140 (Fees For Certification Of Air Permitting Professionals); Rule 3150 (Fees For Portable Equipment Registration); Rule 3155 (Permit-Exempt Equipment Registration Fees); Rule 3160 (Prescribed Burning Fees); Rule 3180 (Administrative Fees For Indirect Source Review); Rule 3190 (Conservation Management Practices Plan Fee): Amendments to the Fees Regulations increase the fees for each of the listed rules by 8% increase effective on the date of rule adoption, and an additional 8% increase starting in fiscal year 2009/2010. The amendments include an hourly permit application evaluation fee so that the District directly recovers the costs of application processing. Contact: Carlos Garcia. Status: Adopted by the Governing Board on January 17, 2008.

Rule 7011 (Hexavalent Chromium - Chrome Plating and Chromic Acid Anodizing Operations): Amendments to Rule 7011 implement the Airborne Toxic Control Measure (ATCM) for Chromium Plating and Chromic Acid Anodizing Facilities that the California Air Resources Board adopted on December 7, 2006. The District is required to implement the ATCM six months after its approval by the Office of Administrative Law which is occurred in September 2007. Contact: Glenn T. Reed. Status: Adopted by the Governing Board on January 17, 2008.

#### **JANUARY 2008**

Rule 7070 (Perchloroethylene from Dry Cleaning Operations): Amendments to Rule 7070 would implement the Airborne Toxic Control Measure (ATCM) for Emissions of Perchloroethylene from Dry Cleaning and Water-Repelling Operations that the California Air Resources Board adopted on January 25, 2007. The District is required to implement the ATCM six months after its approval by the Office of Administrative Law, which occurred in December 2007. Contact: Glenn T. Reed. Status: Workshop was held on January 30, 2008. Governing Board Hearing: May 15, 2008.

# SAN JOAQUIN VALLEY UNIFIED AIR POLLUTION CONTROL DISTRICT SUMMARY OF DRAFT RULES AND PLANS

**February 5, 2008** 

#### **FEBRUARY 2008**

Rule 4306 Phase 3 (Boilers, Steam Generators, and Process Heaters): Amendments to Rule 4306 would implement a NOx control measure commitment in the Ozone Plan, and a control measure in the District's PM2.5 Plan that is currently under development. Amendments would lower the current NOx limits may also establish requirements to reduce PM10 and SO<sub>2</sub> emissions. Contact: Manuel Salinas. Status: First workshop was held on October 30, 2007. Second workshop will be scheduled in late February 2008. Governing Board Hearing: Third Quarter 2008

Rule 4307 (Boilers, Steam Generators, and Process Heaters - 2.0 MMBtu/hr to 5.0 MMBtu/hr): Amendments to Rule 4307 would implement a NOx control measure in the Ozone Plan and a control measure in the District's PM2.5 Plan that is currently under development. Amendments would remove the exemption for boilers, steam generator, and process heaters operated at public and private schools, Kindergarten to Grade 12, and require such units to comply with the rule. Additional amendments would require units in oilfields and refineries, and glycol dehydrators to meet the emission limits instead of just performing tune-ups, and would lower the low-use-unit's annual heat input limit from 5 billion Btu per year to 1.8 billion Btu per year. The amendments may also include requirements to control PM10 and SO<sub>2</sub> emissions. Contact: Manuel Salinas. Status: First workshop was held on October 16, 2007. Second workshop will be scheduled in late February 2008. Governing Board Hearing: Third Quarter 2008.

Rule 4354 (Glass Melting Furnaces): Amendments to Rule 4354 would implement a NOx control measure in the Ozone Plan. Amendments would lower existing NOx limits, reduce the emissions averaging measurement period, and establish new limits for SOx and PM emissions. Contact: Sandra Lowe Leseth. Status: Second workshop and socioeconomic focus group meeting are scheduled for February 8, 2008. Governing Board Hearing: Third Quarter 2008.

Rule 4566 (Greenwaste Composting): New Rule 4566 would implement a VOC Control Measure in the District's 2007 Ozone Plan. The rule would control VOC emissions from composting of greenwaste. Rule 4607 (Graphic Arts): Amendments to Rule 4607 would implement a VOC control measure in the Ozone Plan. Amendments would lower the amount of allowable VOC emissions for exemption, increase the capture and control efficiency of VOC emission control system, reduce the VOC content of limits for flexographic printing, regulate the VOC emissions from digital printing process, and implement recently promulgated EPA Control Technique Guidelines RACT standards for paper, film and foil coatings. **2008 PM2.5 Plan:** The first National Ambient Air Quality Standard for PM2.5 was set in 1997. The Federal Clean Air Act requires the District to develop a PM2.5 plan for submission to EPA by April 2008. Contact: Don Hunsaker. Status: The first workshops were held on December 18 and 19, 2007. The second workshop will be scheduled in March 2008. Governing Board Hearing: April 17, 2008

**Negative Declaration for EPA Control Techniques Guidelines (CTG) for Flatwood Paneling Coatings:** In September 2006 EPA finalized and issued a CTG that established Reasonably Available Control Technology (RACT) standards for flatwood paneling coating operations. The federal Clean Air Act requires ozone nonattainment areas to implement RACT for sources that are subject to the CTG. After reviewing the District Permit database and other available information staff has determined that there are no flatwood paneling manufacturing and coating operations in the SJV. A draft Negative Declaration and related documents will be published for 30-day public commenting period prior to submitting it to the Governing Board for consideration of adoption. Contact: Anna Myers. Status: The draft Negative Declaration was made available for public comment in December 2007. The commenting deadline was January 28, 2008. Governing Board Hearing: March 2008.
