1. CALL TO ORDER—The Chair, Dennis Tristao, called the meeting to order at 10:00 a.m.
2. ROLL CALL—was taken and a quorum was present.

3. APPROVE MINUTES OF OCTOBER 2, 2007—The Minutes for October 2, 2007 were approved as submitted.
4. PUBLIC COMMENTS—There were no public comments.
5. CHAIR COMMENTS—The Chair thanked the CAC for a great year.
6. EXECUTIVE DIRECTOR/APCO COMMENTS—Rick McVaigh, Deputy APCO, stated the Ozone Plan was forwarded by ARB to EPA in November. ARB asked the District to push technology and provide leadership to the Valley. He stated EPA has 18 months to act on the Plan. Mr. McVaigh also noted the Draft PM2.5 Plan was released that morning.

Mr. McVaigh updated the CAC of the upcoming funding programs. He stated the influx of incentive monies will necessitate an expansion of the ERIP Program, and a budget modification will be going to the Board to address that.

Jack Mobley stated ARB currently doesn't allow funding to be used to buy a new truck, but only allows a new engine to replace an old engine. He stated that in some cases, the new engine is worth more than the entire truck. Mr. Mobley would like to know if the District plans on making funds available for truck replacement as well as retrofits. Mr. McVaigh stated ARB is working on the guidelines. The District wants to reduce pollution in the most cost-effective way, and includes retrofits, engine replacements, and full truck replacements in its considerations.

Roger Hoffdahl and Les Clark joined the meeting.

Kevin Hamilton stated it was his understanding that Proposition 1B includes construction costs, and he heard construction companies were trying to get funding for green contracting. Mr. McVaigh stated that may be part of a different discussion, and he would look into it.

7. UPDATE: FAST TRACK TO ATTAINMENT—Rick McVaigh, Deputy APCO, stated the next Fast Track meeting will be held on December 11, 2007. He stated on January 28, 2008 at the Fresno Convention Center, a Short Sea Shipping conference will be held. He stated the Fast Track Task Force is also examining non-profit status for a Community Clean Air Fund, accelerating fleet turnover, and green contracting. He added they are investigating inland ports, and implementing the Healthy Air Living program to promote changing people's attitudes and lifestyles to help improve the air.
8. UPDATE: PROPOSED PM2.5 PLAN—Scott Nester, Director of Planning, stated the Draft PM2.5 Plan was released that morning. He stated the District will attain the standard within the Federal timeframe. Mr. Nester noted PM2.5 has serious health impacts including decreased lung function and heart problems because the particles are small enough to get into the bloodstream and penetrate deep into the lungs.

Mr. McVaigh stated PM2.5 can be issued directly such as from a fireplace, or indirectly from emissions of gasses. He stated the current daily standard is 65 micrograms/cubic meter.

Dean Wilson asked how attainment affects overall air quality of the District. Mr. Nester stated that because a lot of the measures in the PM2.5 Plan and the Ozone Plan overlap, both Plans will improve air quality and Valley residents will have a positive health impact when the Valley reached attainment in PM2.5.

David Harrald asked what percentage of PM2.5 is from mobile sources. Mr. Nester stated that it's difficult to say because PM2.5 is not just from emission of NOx, but also from the dust stirred up by mobile sources as they operate, but approximately 80% of the NOx that forms PM2.5 is from mobile sources.

9. POLLUTION TRANSPORT FROM OTHER AIR BASINS: BETTER QUANTIFY THE MAGNITUDE AND THE IMPACT OF POLLUTION TRANSPORT FROM THE NEIGHBORING AIR BASINS AND PURSUE ACTIONS TO MINIMIZE SUCH IMPACTS—Rick McVaigh, Deputy APCO, introduced the report. He stated that although the majority of pollution in the Valley is self-generated, data from recent wildfires would indicate that there are avenues of pollution transport previously not considered. The District would like to look to see if these new corridors impact Valley pollution on the worst days.

David Nunes, Senior Air Quality Specialist, and James Sweet, Air Quality Project Planner, presented the report. They noted that the current ARB air transport routes do not show the same routes the plumes of smoke from recent fires took, so the District would like to know if there are pollution transport issues that have not been explored. The District would like to

further study how much impact other regions have on Valley air quality, and to see if other districts can help the Valley meet the federal 8-hour ozone standard faster through stricter controls. They stated the District needs to identify resources for evaluating air pollutant transport, analyze existing data for 8-hour events, and review upwind District BARCT measures.

10. APPOINT HEARING BOARD APPOINTMENT SUBCOMMITTEE—The following CAC members were appointed to the Hearing Board Subcommittee:

11. RULES UNDER DEVELOPMENT—Scott Nester, Director of Planning, presented the report. He stated the Rules going to the Board in December are part of the Ozone Plan.

At 11:25 a.m., the VTC System shut down. The system was back up at 11:27 a.m.

12. PUBLIC EDUCATION REPORT— Jaime Holt, Chief Communications Officer, presented the report. Ms. Holt introduced two new Outreach and Communications (OC) employees, Stefanie Sorrells, Air Quality Education Representative, and Claudia Encinas, Bilingual Air Quality Education Representative. She stated Check Before You Burn season is underway, and the OC Program scheduled a media day for local television stations to film District staff to use as file footage. She noted that the District was the first with the “no burn” restrictions, and that neighboring air districts are adopting their own residential burning restrictions. She stated the Environmental Justice Advisory Group is now accepting applications.
13. ARB COMMENTS—Jeff Lindberg, ARB Representative, presented the report. He gave an update of the School Bus Replacement Program, and noted the Valley has 13 pre-1977 busses, and 600 1977-1986 busses. He stated ARB adopted the District’s Ozone Plan as a State Implementation Plan amendment and directed ARB staff to identify what can be done to expedite attainment. To that end, ARB held three town hall meetings, one in each region of the District. ARB strengthened the mobile SIP to double emission reductions by 2017. The remaining reductions may be ¼ of what was originally estimated, but still not attainable with today’s technology. ARB gave staff direction to work with the District to reach attainment by 2017.
14. CAC MEMBER COMMENTS AND CAC SUGGESTIONS TO BE INCLUDED IN THE

PRESENTATION OF THE CAC REPORT DURING THE GOVERNING BOARD MEETING ON THURSDAY, DECEMBER 20, 2007—Dennis Tristao stated he wanted to include the Public Education report in the report to the Governing Board. Kevin Hamilton suggested an update on the new Board Members could be presented at the next CAC meeting. He also requested information on Hydrogen Highways.

RULES AND PLANS ADOPTED IN DECEMBER 2007

Rule 4621 (Gasoline Transfer into Stationary Storage Containers, Delivery Vessels, and Bulk Plants, Rule 4622 (Gasoline Transfer into Motor Vehicle Fuel Tanks), and Rule 4624 (Organic Liquid Loading): Amendments to Rules 4621, 4622, and 4624 would implement VOC control measures in the one-hour Extreme Ozone Plan. Amendments would address the standards for equipment maintenance and repair, inspection frequency, and retrofit or replacement of old systems with newer technologies to reduce VOC emissions. Estimated VOC emissions reduction is about 300 tons/year. Contacts: Sandra Lowe-Leseth and Peter Biscay. **Status: Adopted by the Governing Board on December 20, 2007.**

Aviation Fuel Transfer: Control of emissions from aviation fuel transfer would implement a VOC control measure in the one-hour Extreme Ozone Plan. The VOC control requirements for aviation fuel transfer would be addressed as part of the rule development project to amend Rule 4621, described above. The one-hour Extreme Ozone Plan estimated VOC emissions reduction is about 18 tons/year. Contact: Manuel Salinas. **Status: Adopted by the Governing Board on December 20, 2007.**

The amendments would expand the applicability of the permit application evaluation fee so that the District via assessment of an hourly fee directly recovers the costs of application processing. <p>Rule 4566 (Greenwaste Composting): New Rule 4566 would implement a VOC Control Measure in the District's 2007 Ozone Plan. The rule would control VOC emissions from composting of greenwaste. Contact: Koshuoa Thao. Status: Scoping meeting is scheduled for January 10, 2008. Governing Board Hearing: First Quarter 2009</p>
<p>Rule 4607 (Graphic Arts): Amendments to Rule 4607 would implement a VOC control measure in the Ozone Plan. Amendments would lower the amount of allowable VOC emissions for exemption, increase the capture and control efficiency of VOC emission control system, and reduce the VOC content of limits for flexographic printing. Contact: Anna Myers. Status: Scoping meeting is tentatively scheduled for late January 2008. Governing Board Hearing: Fourth Quarter 2008.</p>
<p>Rule 7011 (Hexavalent Chromium - Chrome Plating and Chromic Acid Anodizing Operations): Amendments to Rule 7011 would implement the revised Airborne Toxic Control Measure (ATCM) for Chromium Plating and Chromic Acid Anodizing Facilities that the California Air Resources Board adopted on December 7, 2006. The District is required to implement the ATCM six months after its approval by the Office of Administrative Law which is expected to occur by September 24, 2007. Contact: Glenn T. Reed. Status: The public workshop was held on October 31, 2007. The Receive and File occurred on December 20, 2008. Governing Board Hearing: January 17, 2008.</p>
<p>Rule 7070 (Perchloroethylene from Dry Cleaning Operations): Amendments to Rule 7070 would implement the revised Airborne Toxic Control Measure (ATCM) for Emissions of Perchloroethylene from Dry Cleaning and Water-Repelling Operations that the California Air Resources Board adopted on January 25, 2007. The District is required to implement the ATCM six months after its approval by the Office of Administrative Law, which should have occurred December 27, 2007. Contact: Glenn T. Reed. Status: Workshop is scheduled for January 30, 2008. Governing Board Hearing: May 15, 2008.</p>
<p>Negative Declaration for EPA Control Techniques Guidelines (CTG) for Flatwood Paneling Coatings: In September 2006 EPA finalized and issued a CTG that established Reasonably Available Control Technology (RACT) standards for flatwood paneling coating operations. The federal Clean Air Act requires ozone nonattainment areas to implement RACT for sources that are subject to the CTG. After reviewing the District Permit database and other available information staff has determined that there are no flatwood paneling manufacturing and coating operations in the SJV. A draft Negative Declaration and related documents will be published for 30-day public commenting period prior to submitting it to the Governing Board for consideration of adoption. Contact: Anna Myers. Status: The draft Negative Declaration was made available for public comment in December 2007. Governing Board Hearing: March 2008.</p>

2008 PM2.5 Plan: The first National Ambient Air Quality Standard for PM2.5 was set in 1997. The Federal Clean Air Act requires the District to develop a PM2.5 plan for submission to EPA by April 2008. Contact: Don Hunsaker. Status: The first workshops were held on December 18 and 19, 2007. The second workshop is tentatively scheduled for February 2008. The Receive and File is scheduled for March 20, 2008. Governing Board Hearing: April 17, 2008

February 2008

Rule 4306 Phase 3 (Boilers, Steam Generators, and Process Heaters): Amendments to Rule 4306 would implement a NOx control measure commitment in the Ozone Plan, and a control measure in the District's PM2.5 Plan that is currently under development. Amendments would lower the current NOx limits and establish requirements to reduce PM10 and SO₂ emissions. Contact: Manuel Salinas. Status: First workshop was held on October 30, 2007. Second workshop is tentatively scheduled for February 2008. Governing Board Hearing: Third Quarter 2008

Rule 4307 (Boilers, Steam Generators, and Process Heaters - 2.0 MMBtu/hr to 5.0 MMBtu/hr): Amendments to Rule 4307 would implement a NOx control measure in the Ozone Plan and a control measure in the District's PM2.5 Plan that is currently under development. Amendments would remove the exemption for boilers, steam generator, and process heaters operated at public and private schools, K1-K12, require such units to comply with the rule. Additional amendments would require units in oilfields and refineries, and glycol dehydrators to meet the emission limits instead of just performing tune-ups, and would lower the low-use-unit's annual heat input limit from 5 billion Btu per year to 1.8 billion Btu per year. The amendments would include requirements to control PM10 and SO₂ emissions. Contact: Manuel Salinas. Status: First workshop was held on October 16, 2007. Rule 4354 (Glass Melting Furnaces): Amendments to Rule 4354 would implement a NOx control measure in the Ozone Plan.
