**RULES ADOPTED IN SEPTEMBER 2009**

**Rule 4692 (Commercial Charbroiling):** Rule amendments would require medium-sized restaurants with chain-driven charbroilers to reduce emissions of particulate matter. Emission reduction estimate of up to 7.3 tons per year of PM10. Contact: Sandra Lowe-Leseth. **Status: The Governing Board adopted the rule amendments on September 17, 2009. The Board also established an incentive grant program to retrofit some under-fired charbroilers with particulate matter controls to evaluate the efficacy of such emission control systems.**

**New Rule 4695 (Brandy Aging and Wine Aging Operation):** The rule would require controls to reduce Volatile Organic Compound emissions generated from larger wine and brandy aging operations. Emission reduction estimate is 43 tons per year of VOC. Contact: Peter Biscay. **Status: Adopted by the Governing Board on September 17, 2009.**

**Rule 4602 (Motor Vehicle Assembly Coatings) and Rule 4653 (Adhesives):** Amendments to Rule 4602 incorporate the emission standards in the Control Technique Guidelines (CTG) for Automobile and Light-Duty Truck Assembly Coatings which EPA promulgated in September 2008. Amendments to Rule 4653 incorporate the emission standards in the CTG for Miscellaneous Industrial Adhesives which EPA promulgated in September 2008. Contact: Anna Myers. **Status: Adopted by the Governing Board on September 17, 2009.**

**Rule 4603 (Surface Coating of Metal Parts and Products) and Rule 4684 (Polyester Resin Operations):** Amendments to Rule 4603 incorporate the emission standards in the Control Technique Guidelines (CTG) for Miscellaneous Metal and Plastic Coatings which EPA promulgated in September 2008. Amendments to Rule 4684 incorporate the emission standards in the CTG for Fiberglass Boat Manufacturing Materials which EPA promulgated in September 2008. Contact: Joe Nazareno. **Status: Adopted by the Governing Board on September 17, 2009.**

**RULES UNDER DEVELOPMENT**

**SEPTEMBER 2009**

**Rule 4103 (Open Burning):** Rule amendments would implement the requirements of the CH&SC Section 41855.5 regarding the prohibition of the open burning of certain agricultural materials, which will take effect on June 1, 2010. In addition, it would implement Phase IV of the open burning control measure listed in the District's Ozone Plan and PM2.5 Plan. Projected emission reduction estimates, from all burn prohibition phases, are 1.95 tons per day of NOx, 2.57 tons per day of PM10, and 0.5 tons per day of SO2. Contact: Saul Gamez. Status: Scoping meeting was held on September 8, 2009. The first workshop will be scheduled for November 2009. Governing Board Hearing: First Quarter 2010.

**Rule 4566 (Organic Waste Operations):** This new rule would implement a VOC Control Measure in the District's 2007 Ozone Plan. The rule would control VOC emissions from organic waste operations which include composting, chipping and grinding, landfilling, land applying, storing or stockpiling, direct feeding, and dehydration. Emission reduction estimate is 9 tons per day of VOC. Contact: Koshoua Thao. Status: The contractor collected the last sample on September 14, 2009, and plans to complete the analyses to determine best management practices, which can be incorporated into the rule. District staff held a Composting Technical Workgroup meeting on September 15, 2009. Governing Board Hearing: Fourth Quarter 2010.

**RULES UNDER DEVELOPMENT (continued)**

**OCTOBER 2009**

**Rule 9410 (Employer Based Trip Reduction):** Rule amendments would implement a control measure in the Ozone and PM2.5 Plans. The project would require large employers to establish employee trip reduction programs, choosing from a menu of options designed to facilitate the use of ridesharing and alternative transportation. Employers would also conduct semiannual employee surveys, though the rule would not mandate a particular level of employee participation in ridesharing and alternative transportation. Emission reduction estimate will be calculated during rule development. Contacts: Nichole Corless and Jessica Fierro. Status: Second Workshop was held on September 14, 15, and 16, 2009. The final workshop will be scheduled for October 26 and 27, 2009. Governing Board Hearing: Fourth Quarter 2009.

**Rule 4570 (Confined Animal Facilities):** Due to a court decision, the existing rule was set aside by the Governing Board on May 21, 2009. After consideration of the health impact study, the Board re-adopted the rule at the June meeting. Rule development of draft amendments to existing Rule 4570 pursuant to the Ozone Plan has resumed. The Ozone Plan's estimated VOC emission reduction is about 23 tons/day by 2023. Contact: Sandra Lowe-Leseth. **Status:** First workshop will be scheduled for late October or early November 2009. Governing Board: First Quarter 2010.

**NOVEMBER 2009**

**Rule 2301 (Emission Reduction Credit Banking):** Amendments to Rule 2301 would establish a method of banking carbon emission credits from local emission reduction projects. Methodology would be consistent with state carbon banking guidelines. Contact: Leonard Scandura. Status: The second public workshop was held on June 30, 2009. The Receive and File was held on September 17, 2009. **Governing Board Hearing: November 5, 2009.**

**Rule 4308 (Boilers, Steam Generators, and Process Heater, rated 0.075 to <2.0 MMBtu/hr):** Rule amendments would implement a NOx control measure in the Ozone and PM2.5 Plans. The project will require new and replaced units to meet lower NOx limits. Emission reduction estimate is 2.8 tons per day of NOx. Contact: Katy Linebach. Status: The final workshop was held on September 1, 2009. The Receive and File will be scheduled for November 5, 2009. **Governing Board Hearing: December 17, 2009.**

**Rule 4601 (Architectural Coatings):** Rule amendments would lower the VOC content limits of several coating categories to make them consistent with the state-wide Suggested Control Measure that was adopted by ARB in October 2007. Emission reduction estimate is 2.1 tons per day of VOC. Contact: Anna Myers. Status: Final workshop was held on September 15, 2009. The Receive and File will be scheduled for November 5, 2009. **Governing Board Hearing: December 17, 2009.**

**FOURTH QUARTER 2009**

**Rule 4905 (Natural Gas-Fired, Fan-Type Residential Central Furnaces):** Rule amendments would implement a control measure (S-COM-10) in the Ozone Plan and PM2.5 Plan. Amendments would lower the existing NOx limits by requiring manufacturers to install low-NOx burner technology on new units prior to being sold to the public. Emission reduction estimate will be calculated during rule development. Contact: George Heinen. Status: Scoping meeting was held on May 29, 2009. First workshop will be scheduled for Fourth Quarter 2009. Governing Board Hearing: Second Quarter 2010.
