- CALL TO ORDER—The Chair, Dennis Tristao, called the meeting to order at 10:03 a.m.

- 3. <u>APPROVE MINUTES OF SEPTEMBER 4, 2007</u>—The Minutes for September 4, 2007 were approved as submitted.
- 4. <u>PUBLIC COMMENTS</u>—Mary Darling stated she recently received a public notice mailing regarding expansion of a nearby facility. She requested a 30day extension of the comment period to increase opportunity for public input.

Tate Hill, Fresno West Coalition for Economic Development, stated the Project is C-1070484, and the Public Notice was dated September 5, 2007. He requested a 30-day extension of the comment period to give the community a voice.

Keith Kelley, Fresno West Coalition for Economic Development, referred to the same project as the previous commenters, and requested a 30 day extension in the public comment period.

Rick McVaigh noted the notices sent to the public were not required by law, but the District wants to keep people informed. He requested Dave Warner come to meet with the public who were present. Mr. Warner spoke with the public members privately.

- 5. <u>CHAIR COMMENTS</u>—The Chair noted the first meeting in 2008 is scheduled for Tuesday, January 8, due to the New Year's Day holiday. He also noted his Chairmanship ends on January 31, 2008, and the next Chair will come from the Environmental Interest Group.
- 6. <u>EXECUTIVE DIRECTOR/APCO COMMENTS</u>—Rick McVaigh, Deputy APCO, gave the updates. He noted ARB adopted the State's strategies for the District's Ozone Plan and forwarded it to EPA. The measures under District Control in the Ozone Plan should go to EPA in November. Mr. McVaigh stated the District wants the State to take a closer look at air transport from other areas. He noted the District's Annual Symposium is on October 3-4, and the focus is on the Fast Track to Attainment, including goods movement

and self-help measures. Mr. McVaigh informed the CAC that ARB has a meeting on October 10 to discuss disbursement of Proposition 1B funds, which are slated to reduce the air quality impacts of goods movement. Mr. McVaigh noted the Governing Board meeting was moved to October 25, 2007.

Dean Wilson asked if the District had a measurement of the amount of pollution in the Valley that comes from the Bay Area. Mr. McVaigh stated the current measurement is 30% of Bay Area pollution in the Northern Valley, dropping to 6% in the Southern part of the Valley. He noted the facts have changed since those numbers were estimated, and the District would like it studied further. Mr. Wilson asked how the CAC and members of the public could write to the legislature to encourage mobile source restrictions. Mr. McVaigh said District staff will follow up.

Randall Blank asked if Rules are adopted as is. George Heinen, Supervising Air Quality Engineer, stated there are sometimes minor changes. Staff posts the final versions of the Rules as soon as possible.

Mary-Michal Rawling requested a presentation on air transport for the next CAC meeting.

Chris Dodsen asked about the Boiler Rule timeframe. Mr. Heinen stated it is in the development for the next year.

Rico Aguayo asked that the Annual Symposium documents be posted to the District's website.

David Harrald stated the District should look at alternative methods of brush removal rather than controlled burns. Mr. Heinen stated he would look at the feasibility of alternative methods and report back in 3 months.

Gary Rohman would like to see the District educate Valley residents and businesses on the SOON Program. Mr. McVaigh started the District plans on doing that, but first must raise funds, and hold some public workshops.

7. <u>UPDATE: FAST TRACK TO ATTAINMENT</u>—Rick McVaigh, Deputy APCO, stated the District has three proposals to pursue as part of Fast Track: putting pressure on EPA and ARB regarding more stringent mobile source regulations, obtaining incentives, and pursuing innovative Fast Track measures. The District has worked with ARB to add the SOON program which will reduce NOX by 4 tons per day.. The District has also been able to persuade ARB to move timelines forward on truck emissions reductions from 2020 to 2017. The incentive funding focus has been on Proposition 1B funds. Mr. McVaigh stated innovative Fast Track measures have the potential to make big dents in air pollution, but were not ready to be included in the legal state Ozone Plan. These measures will be discussed in detail during the Annual Symposium on October 3-4 in Visalia.

8. <u>UPDATE: PROPOSED PM2.5 PLAN</u>—Rick McVaigh, Deputy APCO, presented the report. He stated there is a workshop for PM2.5 tentatively scheduled for November 14, 2007. The Draft PM2.5 Plan should be available on October 31.

Mary-Michal Rawling asked if there would be more than one workshop, and if the report would go to the Board in January. Mr. McVaigh replied that it is unknown if there will be a second round of workshops, and that February would be the soonest month the Plan would be submitted to the Board.

Kevin Hamilton stated he felt there should be more than one workshop. He asked if the District can achieve the PM2.5 standard by 2015. Mr. McVaigh stated the District believes it can reach attainment by 2015.

<u>CAC APPOINTMENTS TO THE ENVIRONMENTAL JUSTICE ADVISORY GROUP</u> (EJAG)—The interest groups named the following members to the EJAG:

Rick stated the District will contact Environmental Justice groups and obtain interest from them on membership on the EJAG.

 <u>RULES UNDER DEVELOPMENT</u>—George Heinen, Supervising Air Quality Engineer, presented the report. He noted four rules were passed at the last Governing Board meeting. Mr. Heinen stated the Summary of Draft Rules and Plans, under Rule 4703, it should read "Estimated NOx emissions reductions is 800 tons/year" not "Estimated VOC."

Dean Wilson suggested instead of having large Rule packets mailed to people, there could be a postcard notification with the URL directing people where to go. Mr. Heinen responded that there is an email notification list people can subscribe to and receive notification via email with the link to the Rule. Mr. Wilson suggested sending letters out to everyone receiving the packets. The Clerk responded that the Operations and Program Support staff are currently working on letters to subscribers for the same purpose.

11. <u>PUBLIC EDUCATION REPORT</u>— Janelle Schneider, Air Quality Education Representative stated the District's Annual Symposium is being held on October 3-4 in Visalia. She stated entries for the Kid's Calendar are due by October 15, 2007. Ms. Schneider stated in 2007, there were a total of six Spare the Air declarations in the Valley compared to 23 in 2006, 18 in 2005, 27 in 2004, and 41 in 2003. She added that the Check Before You Burn program begins on November 1, 2007. The District is also planning another wood burning stove change-out program for February, but has no details at this time.

David Harrald asked if the forest fires were related to Spare the Air. Mr. McVaigh stated there was a day of high ozone, but not an exceedence of the ozone standard, that the District believes was related to the fires.

12. <u>ARB COMMENTS</u>—Jeff Lindberg, ARB Representative, presented the report. He stated there are upcoming workshops in October regarding on-road heavy duty trucks. He noted all workshops are on the ARB website.

Kevin Hamilton asked what the status of the school bus replacement is. Mr. Lindberg stated that he did not have that information and would have to follow up. Mr. Hamilton stated that ARB should prepare a chart comparing the Districts. Mr. Lindberg stated he would take that back to ARB.

13. <u>CAC MEMBER COMMENTS AND CAC SUGGESTIONS TO BE INCLUDED IN THE</u> <u>PRESENTATION OF THE CAC REPORT DURING THE GOVERNING BOARD MEETING</u> <u>ON THURSDAY, OCTOBER 25, 2007</u>—Mary-Michal Rawling wanted to know if the District has received any feedback regarding the webcast. Chris Savage requested a report on CEQA.

David Harrald suggested the wildfire information be included in the report to the Governing Board. The Chair added that the EJAG appointments should be included.

RULES AND PLANS UNDER DEVELOPMENT

DECEMBER 2007

Rule 4621 (Gasoline Transfer into Stationary Storage Containers, Delivery Vessels, and Bulk Plants, Rule 4622 (Gasoline Transfer into Motor Vehicle Fuel Tanks), and Rule 4624 (Organic Liquid Loading): Amendments to Rules 4621, 4622, and 4624 would implement VOC control measures in the one-hour Extreme Ozone Plan. Amendments would address the standards for equipment maintenance and repair, inspection frequency, and retrofit or replacement of old systems with newer technologies to reduce VOC emissions. Estimated VOC emissions reduction is about 300 tons/year. Contacts: Sandra Lowe-Leseth and Peter Biscay. Status: The final workshop was held on July 23 and 24, 2007. Governing Board Hearing: December 20, 2007.

Aviation Fuel Transfer: Control of emissions from aviation fuel transfer would implement a VOC control measure in the one-hour Extreme Ozone Plan. The VOC control requirements for aviation fuel transfer would be addressed as part of the rule development project to amend Rule 4621, which currently in progress. The one-hour Extreme Ozone Plan estimated VOC emissions reduction is about 18 tons/year. Contact: Manuel Salinas. Status: Final workshop for Rule 4621 was held on July 23 and 24, 2007. **Governing Board Hearing: December 20, 2007.**

Regulation III (Fees): Rule 3010 (Permit Fee); Rule 3020 (Permit Fee Schedules); Rule 3030 (Hearing Board Fees); Rule 3040 (Open Burning Fees; Rule 3050 (Asbestos Removal Fees); Rule 3060 (Emission Reduction Credit Banking Fee); Rule 3070 (Other Charges); Rule 3080 (Atmospheric Acidity Protection Act Program Fee); Rule 3090 (California Clean Air Act Fees); Rule 3110 (Air Toxics Fees); Rule 3120 (Regulation VIII Alternative Compliance Plan Review Fee); Rule 3135 (Dust Control Plan Fee): Rule 3140 (Fees For Certification Of Air Permitting Professionals): Rule 3150 (Fees For Portable Equipment Registration); Rule 3155 (Permit-Exempt Equipment Registration Fees); Rule 3160 (Prescribed Burning Fees); Rule 3180 (Administrative Fees For Indirect Source Review); Rule 3190 (Conservation Management Practices Plan Fee): Amendments to the Fees Regulation would consist of an eight percent increase in most of the District fees effective on the date of rule adoption, a second 8% increase effective on July 1, 2009, and an expansion of the applicability of the permit application evaluation fee so that the costs of application processing are directly recovered by the District via assessment of an hourly fee. Contact: Carlos Garcia. Status: First workshop held on September 5, 2007. The Receive and File is scheduled for December 20, 2007. Governing Board Hearing: January 17, 2008.

2008 PM2.5 Plan: The first National Ambient Air Quality Standard for PM2.5 was set in 1997. The Federal Clean Air Act requires the District to develop a PM2.5 plan for submission to EPA by April 2008. Contact: Don Hunsaker. Status: First workshop is scheduled for December 18 and 19, 2007. The Receive and File is tentatively scheduled for March 20, 2008. Governing Board Hearing: April 17, 2008

Rule 7011 (Hexavalent Chromium - Chrome Plating and Chromic Acid Anodizing Operations): Amendments to Rule 7011 would implement the revised Airborne Toxic Control Measure (ATCM) for Chromium Plating and Chromic Acid Anodizing Facilities that the California Air Resources Board adopted on December 7, 2006. The District is required to implement the ATCM six months after its approval by the Office of Administrative Law which is expected to occur by September 24, 2007. Contact: Glenn T. Reed. Status: Workshop was held on October 31, 2007. The Receive and File is tentatively scheduled for December 20, 2008. Governing Board Hearing: January 17, 2008.

JANUARY 2008

Rule 4306 Phase 3 (Boilers, Steam Generators, and Process Heaters): Amendments to Rule 4306 would implement a NOx control measure commitment in the Ozone Plan, and a control measure in the District's PM2.5 Plan that is currently under development. Amendments would lower the current NOx limits and establish PM10/2.5 and SO₂ emission limits. Contact: Manuel Salinas. Status: First workshop was held on October 30, 2007. Second workshop is tentatively scheduled for January 2008. Governing Board Hearing: June 2008

Rule 4307 (Boilers, Steam Generators, and Process Heaters - 2.0 MMBtu/hr to 5.0 MMBtu/hr): Amendments to Rule 4307 would implement a NOx control measure in the Ozone Plan. Amendments would remove the exemption for boilers, steam generator, and process heaters operated at public and private schools, K1-K12, and require such units to comply with the rule. Additional amendment would include lowering the low-use-unit limit from 5 billion Btu per year to 1.8 billion Btu per year of heat input. Contact: Manuel Salinas. Status: First workshop was held on October 16, 2007. Second workshop is tentatively scheduled for January 2008. Governing Board Hearing: June 2008.

Rule 4566 (Greenwaste Composting): New Rule 4566 would implement a VOC Control Measure in the District's 2007 Ozone Plan. The rule would control VOC emissions from composting of greenwaste. Contact: Koshuoa Thao. Status: Scoping meeting is scheduled for January 10, 2008. Governing Board Hearing: First Quarter 2009

Rule 4607 (Graphic Arts): Amendments to Rule 4607 would implement a VOC control measure in the Ozone Plan. Amendments would lower the amount of allowable VOC emissions for exemption, increase the capture and control efficiency of VOC emission control system, and reduce the VOC content of limits for flexographic printing. Negative Declaration for EPA Control Techniques Guidelines (CTG) for Flatwood Paneling Coatings: In September 2006 EPA finalized and issued a CTG that established Reasonably Available Control Technology (RACT) standards for flatwood paneling coating operations. The federal Clean Air Act requires ozone nonattainment areas to implement RACT for sources that are subject to the CTG. After reviewing the District Permit database and other available information staff has determined that there are no flatwood paneling manufacturing and coating operations in the SJV. A draft Negative Declaration and related documents will be published for 30-day public commenting period prior to submitting it to the Governing Board for consideration of adoption. Contact: Anna Myers. Status: The draft Negative Declaration will be available for public comment in December 2007. Governing Board Hearing: February 2008.

JANUARY 2008

Rule 4354 (Glass Melting Furnaces): Amendments to Rule 4354 would implement a NOx control measure in the Ozone Plan. Amendments would lower existing NOx limits, reduce the allowable duration of time of start-up and shutdown, reduce the emissions averaging measurement period, and establish new limits for SOx and PM emissions.
