- 1. <u>CALL TO ORDER</u> The Chair, Dennis Tristao, called the meeting to order at 10:01 a.m.

- 3. <u>APPROVE MINUTES OF, APRIL 3, 2007 AND, JUNE 5, 2007</u> The Minutes for April 3, 2007 and June 5, 2007 were approved as submitted.
- 4. Public Comments None
- 5. <u>CHAIR COMMENTS</u> The Chair noted that a request was made to limit the length of the CAC meetings. He stated he would meet with the Chairs of the Interest Groups—Amarpreet Dhaliwal, Mary-Michal Rawling, Chris Savage—to discuss the request and come up with a solution to keep meetings brief while ensuring the public and CAC members have full participation.
- 6. EXECUTIVE DIRECTOR/APCO COMMENTS Rick McVaigh, Deputy APCO, stated that as of July 31, the Valley had only one exceedence of the one-hour ozone standard. During the same time period, the Valley experienced 40 exceedences of the eight-hour ozone standard, with most of those in South Kern County and remote parts of Tulare County. Mr. McVaigh stated the PM2.5 (ultra fine particulate matter) Plan is due to EPA in April 2008. He stated there are two causes of PM2.5—direct (emitted from vehicles and industry), and indirect (forming in the atmosphere). He added that 90% of the NOx controls needed to meet the PM2.5 plan were included in the Ozone Plan. He stated PM2.5 is of more concern in the winter, so the District plans on looking at residential heating and fireplace rules to help limit the emissions that cause PM2.5. Mr. McVaigh stated preliminary modeling from ARB shows that, with effort and funding, the District should be able to meet the 2015 deadline.

Mr. McVaigh stated the PM10 Maintenance Plan is scheduled for a workshop on August 8, 2007. He noted that as of September 2006, the District is in compliance for PM10, which is four years ahead of schedule. The Plan is to maintain compliance, and all measures proposed in the original PM10 Plan will be retained.

<u>CAC Member Comments</u>: Lee Smith asked what the residential heating controls would be. Mr. McVaigh responded that the controls are generally at the point of sale and not retrofits.

Mary-Michal Rawling asked how the PM2.5 Plan will work out if the District fails to get any funding. Mr. McVaigh stated the Plan hasn't been completed as the District is waiting on data from ARB, and the District is working on additional funding. He noted the draft PM2.5 Plan should have a workshop in October or November. Ms. Rawling requested an update on the PM2.5 Plan be included as a standing item on the agenda, and the Chair concurred.

7. <u>UPDATE: FAST TRACK TO ATTAINMENT</u>—Rick McVaigh, Deputy APCO, stated the goal of the Fast Track to Attainment is to beat the Ozone Plan deadline of 2024. He stated a Fast Track Task Force meets every Tuesday to discuss different solutions. One of the goals of the Task Force is to encourage the State and Federal governments to do their share in funding and regulations. Another goal is go get funding to incentivize replacement. Finally, the third goal is to develop innovative measures that the District had looked at but could not add to the Plan.

Mr. McVaigh stated ARB proposed a stringent new Rule on construction equipment in May with a cost estimate between \$3 billion and \$13 billion. The District provided testimony and asked ARB to make the Rule even more stringent. Additionally, the District had the opportunity to develop an enhancement called SOON (South Coast San Joaquin Valley Off Road Opt In for NOx). This proposal would provide an additional 2.5 tons/day reduction of NOx in the Valley, and represents a significant success for our Fast Track efforts. The District has committed \$5 million/year in Carl Moyer funds, and is asking ARB to add an additional \$5 million/year in multi-district Carl Moyer funds. The Rule was adopted on July 26, 2007 with the enhancement program. He noted that the construction industry will be spending billions of dollars to comply with this Rule.

Mr. McVaigh stated the Task Force wants to make sure the Valley gets its fair share of the Prop 1B funds earmarked to mitigate air pollution caused by goods movement. With the major North-South goods movement corridor running through the Valley, Interstate 5 and Highway 99, 40% of the NOx pollution in the Valley is from heavy duty trucks moving goods. He stated the language in the legislature thus far looks promising that the Valley will receive its fair share. Mr. McVaigh added that Senator Feinstein has proposed \$7.5 million for diesel projects to go to the Valley with an additional \$7.5 million going to South Coast. He stated this is a significant move as it shows the Federal legislatures are recognizing that they can help with the Valley's air quality.

Mr. McVaigh stated \$150 million for the EQUIP program is included in the Federal Farm Bill.

Mr. McVaigh described some of the innovative programs the Task Force has discussed such as truck replacements, enhancing Spare the Air, Marine

Highways, and the Community Clean Air Fund which would allow private citizens to donate money to help air quality.

<u>CAC Member Comments</u>: Isaac George asked if the District could provide funds for helping cities and counties prepare or revise their general plans to include an air quality component. Mr. McVaigh stated he would follow up on that idea. The Chair noted that the District has air quality development guidelines on their internet site, www.valleyair.org.

Les Clark asked if the District was looking at retrofitting all buses, school buses and other types. Mr. McVaigh stated he would follow up on that as well.

Gary Rohman noted that the SOON program is for 20,000 hp and greater engines and fleets with a mix of Tier 0 and Tier 1 engines, which is not all contractors.

Amarpreet Dhaliwal noted that the Fresno Council of Governments has funds to assist with the development of General Plans, and suggested cities contact their Council of Governments for more information.

Rico Aguayo asked what portion of Prop 1B funds would be for the Valley. Mr. McVaigh stated the total is \$250 million, and the first year criteria is very important as it will drive the fund distribution in later years, so the District is active in influcing the funding decisions. The District believes a significant share of the money should go to the Valley.

8. RULES UNDER DEVELOPMENT

George Heinen, Rule Development Supervisor, presented the report. He noted that the PM 2.5 Plan will not be taken to a public workshop in August as stated in the Summary as the District is waiting for more data from ARB and EPA.

<u>CAC Member Comments</u>: Randall Blank stated he believes that Rule 4703 puts the City of Lodi's electrical grid stability at risk.

Chris Dodson noted that the District is targeting turbines over 10 megawatts. Mr. Heinen stated that turbines of over 10 megawatts that operate more than 877 hours are impacted by Rule 4703, but the District is still meeting with stakeholders. Mr. Dodson stated the Rule reduces CO limits from 200 to 80, but Mr. Heinen stated that based on comments from stakeholders and workshop participants, that reduction has been removed.

Sarah Sharpe asked if the Governing Board approval date will change for the PM 2.5 Plan based on the change of workshop date. Mr. Heinen stated that is unclear at this time.

9. Public Education Report

Janelle Schneider presented the report. She noted the Spare the Air commercials have begun airing. She stated that four Spare the Air dates were announced for the Central Region, five for the Southern Region, and two for the Northern Region. Ms. Schneider informed the CAC that the District Symposium will be held on October 3-4, 2007 in Visalia. She stated that Seyed Sadredin, Executive Director, has appeared on recent radio programs, and recorded a one hour program for Clear Channel Radio to air on 8 stations. Ms. Schneider added that school curriculum packets are going out to teachers soon.

<u>CAC Member Comments</u>: Sarah Sharpe noted that she has seen the ads airing at 4:00 a.m. and wondered if that was the best use of the District's money. Ms. Schneider responded that there is a specific demographic being targeted, and it's possible that demographic is watching at 4:00 a.m, and that ads were also airing at other times.

Amarpreet Dhaliwal asked if Punjabi language radio stations are being targeted. Ms. Schneider stated that is one of their top priorities.

Mary-Michal Rawling asked for the Symposium times. Ms. Schneider stated that she could send Ms. Rawling that information.

The Chair asked what is included in the school curriculum. Ms. Schneider stated it includes a teacher's guide for Kindergarten through second grade, and one for third grade through fifth, stickers, pencils, and pens. She stated she could bring a packet to the next CAC meeting.

RULES AND PLANS UNDER DEVELOPMENT

SEPTEMBER 2007

Rule 46xx Organic Solvents: Amendments to the existing District coating rules would implement a VOC control measure in the Ozone Plan. Amendments would lower the existing the VOC limits of organic cleaning solvents used in numerous coating operations including metal parts, automotive and mobile equipment, wood products, graphic arts, aerospace assembly and components, degreasing operation, can and coil coating, glass coating, adhesive applications, and polyester resin operations. Estimated VOC emissions reduction is about 1,204 tons/year. Contact: Sandra Lowe-Leseth. **Governing Board Hearing: September 20, 2007.**

Rule 4651 (Soil Decontamination): Amendments to Rule 4651 would implement a VOC control measure in the Ozone Plan. The rule would incorporate exemptions, limits, practices, monitoring, and recordkeeping requirements to ensure the rule is as stringent as other air districts' rules and meets BACM, BACT, and RACT standards. Estimated VOC emissions reduction is about 10 tons/year. Contact: Koshoua Thao. **Governing Board Hearing: September 20, 2007.**

Rule 4682 (Polymeric Foam Manufacturing): Amendments to Rule 4682 would address the VOC emissions of the storage and curing of foam products. The one-hour Extreme Ozone Plan estimated VOC emissions reduction is about 146 tons/year. Contact: Manuel Salinas. Governing Board Hearing: September 20, 2007.

Rule 4703 (Stationary Gas Turbines): Amendments to Rule 4703 would implement a NOx control measure in the one-hour Extreme Ozone Plan. The amendments would further control emission from existing turbines used for distributed power generation. The one-hour Extreme Ozone Plan estimated NOx emissions reduction is about 219 tons/year. Contact: Saul Gamez. Governing Board Hearing: September 20, 2007.

2007 PM10 Maintenance Plan and Request for Redesignation: The federal Clean Air Act requires the District to submit a PM10 Maintenance Plan (Plan) so that EPA could complete the process of re-designating the District in attainment of the PM10 NAAQS. The Plan is intended to demonstrate continued attainment for 10 years after EPA re-designates the District. Staff anticipates EPA's action on the re-designation request would be complete in 2009. Regulation III (Fees): Rule 3010 (Permit Fee); Rule 3020 (Permit Fee Schedules); Rule 3030 (Hearing Board Fees); Rule 3040 (Open Burning Fees; Rule 3050 (Asbestos Removal Fees); Rule 3060 (Emission Reduction Credit Banking Fee); Rule 3070 (Other Charges); Rule 3080 (Atmospheric Acidity Protection Act Program Fee); Rule 3090 (California Clean Air Act Fees); Rule 3110 (Air Toxics Fees); Rule 3120 (Regulation VIII Alternative Compliance Plan Review Fee); Rule 3135 (Dust Control Plan Fee); Rule 3140 (Fees For Certification Of Air Permitting Professionals); Rule 3150 (Fees For Portable Equipment Registration); Rule 3155 (Permit-Exempt Equipment Registration Fees); Rule 3160 (Prescribed Burning Fees); Rule 3180 (Administrative Fees For Indirect Source Review); Rule 3190 (Conservation Management Practices Plan Fee): Amendments to the Fees Regulation would consist of an eight percent increase in most of the District fees, and an expansion of the applicability of the permit application evaluation fee so that the costs of application processing are directly recovered by the District via assessment of an hourly fee. Contact: Carlos Garcia. Status: Public workshop is scheduled for September 5, 2007. Governing Board Hearing: December 20, 2007.

OCTOBER 2007

Rule 4354 (Glass Melting Furnaces): Amendments to Rule 4354 would implement a NOx control measure in the Ozone Plan. Amendments would lower existing NOx limits, reduce the allowable duration of time of start-up and shutdown, reduce the emissions averaging measurement period, and establish new limits for SOx and PM emissions. Contact: Sandra Lowe Leseth. Status: Scoping meeting was held on June 4 and 5, 2007. The first workshop is tentatively scheduled for October 2007. Governing Board Hearing: Third Quarter 2008.

Rule 4621 (Gasoline Transfer into Stationary Storage Containers, Delivery Vessels, and Bulk Plants, Rule 4622 (Gasoline Transfer into Motor Vehicle Fuel Tanks), and Rule 4624 (Organic Liquid Loading): Amendments to Rules 4621, 4622, and 4624 would implement VOC control measures in the one-hour Extreme Ozone Plan. Amendments would address the standards for equipment maintenance and repair, inspection frequency, and retrofit or replacement of old systems with newer technologies to reduce VOC emissions. Estimated VOC emissions reduction is about 300 tons/year. Contact: Peter Biscay. Status: The final workshop was held on July 23 and 24, 2007. The Receive and File is scheduled for October 2007. Governing Board Hearing: December 20, 2007.

Aviation Fuel Transfer: Control of emissions from aviation fuel transfer would implement a VOC control measure in the one-hour Extreme Ozone Plan. The VOC control requirements for aviation fuel transfer would be addressed as part of the rule development project to amend Rule 4621, which currently in progress. The amendments to Rule 4621 would include provisions to reduce VOC emissions during aircraft refueling operations by requiring Phase I emission control system. Phase I control would regulate filling aviation fuel bulk storage tanks using primary fuel delivery trucks as wells as filling an airport's fuel delivery trucks from bulk storage tanks. It does not include filling an aircraft's on-board fuel tanks. The one-hour Extreme Ozone Plan estimated VOC emissions reduction is about 18 tons/year. Contact: Manuel Salinas. Rule 7011 (Hexavalent Chromium - Chrome Plating and Chromic Acid Anodizing Operations): Amendments to Rule 7011 would implement the revised Airborne Toxic Control Measure (ATCM) for Chromium Plating and Chromic Acid Anodizing Facilities that the California Air Resources Board adopted on December 7, 2006. The District is required to implement the ATCM six months after its approval by the Office of Administrative Law which is expected to occur by September 24, 2007. Contact: Glenn T. Reed. Status: Workshop is tentatively scheduled for October 2007. Governing Board Hearing: January 2008.

2008 PM2.5 Plan: The first National Ambient Air Quality Standard for PM2.5 was set in 1997. The Federal Clean Air Act requires the District to develop a PM2.5 plan for submission to EPA by April 2008. Contact: Don Hunsaker. Status: First workshop is tentatively scheduled for late Fall. The final Plan is due to the EPA by April 5, 2008.
