- 1. <u>Call Meeting to Order</u> Lee Smith, Chairman, requested that Bruce Rudd, Vice Chairman chair the meeting today. The Vice Chairman, Bruce Rudd, called the meeting to order at 9:30 a.m.

- 3. <u>Chairman Comments</u> The Vice Chairman noted that the CAC looks forward to a challenging year. The Vice Chairman stated that this year possible poses some of the greatest opportunities for the Valley. As far as establishing a set of guidelines or improvements that are going to be necessary for us to meet the air quality challenges that we are all hoping to achieve. At least, if not in our life time then sometime in the next twenty or thirty years. That will come with some challenges and some understanding by both parties and by working together we can achieve that goal.
- 4. Comments of Appreciation to Wade Broughton, Vice Chairman for 2000/2001 The Chairman, Lee Smith, stated that the CAC extends our appreciation to Wade Broughton for serving as Vice Chairman during 2000/2001 and for taking on the responsibilities as Chairman of the CAC for the last few months.
- 5. APCO Comments David L. Crow, Executive Director/APCO, wished everybody a *Happy New Year!* Mr. Crow reported on Governing Board actions taken on December 20, 2001 and listed items on the upcoming Governing Board agenda for January 17, 2002. Mr. Crow noted that the District will be conducting workshops on the 2002 Amendment to SJV Ozone Plan and Severe Versus Extreme Nonattainment Area Designation. Mr. Crow announced the dates for the workshops: January 8, 2002 at 1:30 p.m., January 9, 2002 at 6:30 p.m., and January 16, 2002 at 1:30 p.m. Mr. Crow indicated that the video teleconferencing system will be utilized for all three workshops.

Mr. Crow noted that Dave Jones, Planning Manager, will provide the CAC with an overview of what the District will be presenting in the workshops in respect to the *2002 Amendment to SJV Ozone Plan and Severe Versus Extreme Nonattainment Area Designation Workshops.* Mr. Crow noted that the purpose of this presentation is to invite not only CAC comments and participation but also for the CAC to go ring the bell loudly in various communities around the

region to invite folks to participate. Mr. Jones made his presentation and answered questions from the CAC.

- 6. Approve Minutes of Tuesday, December 4, 2001 The Vice Chairman asked if there were any corrections, additions or comments regarding the Minutes of December 4, 2001. The CAC did not have any corrections, additions or comments. The Vice Chairman declared the Minutes of December 4, 2001 were approved as submitted.
- 7. Public Education Josette Merced Bello, Public Education Administrator, introduced the most recent addition to the Public Education staff: Ms. Stacey Galati who joined the District in December as the Northern Region Education Representative. Ms. Bello noted that Ms. Galati will be working out of the Modesto office and doing research in Merced, San Joaquin and Stanislaus counties.

Ms. Bello announced that the 2002 kid's art calendars were available. Ms. Bello noted that some calendars are still available and to please contact Public Education if you need anymore.

Ms. Bello stated that Public Education has started theater advertising to promote cleaner burning tips for those using their fireplaces this winter. Due to wet weather the District has not asked for the public to curtail wood burning so far this winter.

Ms. Bello announced that Public Education is in the process of setting dates for the *Clean Green Yard Machines* events this spring. They are tentatively set for the latter three weeks in April. Mr. Bello noted that this year, we will ask everyone who is interested to call the office for a lottery-type selection process.
