5. The Central Region Hearing Board granted the following emergency variances since the September 19, 2012, Hearing:

A. Docket C-12-10E – Chevron USA, Inc.

On September 19, 2012, Hearing Board Chair, Mr. Jerry Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from September 19, 2012, until October 18, 2012. Said variance provided relief from specific requirements of District Rules 2010, 2070.7.0, 2201, 2520, and 4623, and allowed for the continued operation of the tank vapor recovery system even though the vapors were not being incinerated in the 25D Steam Plant steam generators because they had to be taken offline.

B. Docket C-12-11E – Naval Air Station Lemoore

On September 20, 2012, Hearing Board Chair, Mr. Jerry Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from September 20, 2012, until October 19, 2012. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, and 2520, and allowed jet engine test cells #3 and #4 to exceed the daily fuel usage limit.
