5. The Central Region Hearing Board heard and granted the following emergency variance since the November 20, 2013, hearing:
  - A. C-13-20E - Chevron USA Inc.

On December 9, 2013, Hearing Board Chair, Mr. Jerry K. Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from December 9, 2013, until January 7, 2014. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, 4401, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks without a functional or operating vapor recovery system. It also allowed that collected vapors do not have to be incinerated in the steam generators as stated in the permits.
