5. The Central Region Hearing Board heard and granted the following emergency variances since the December 18, 2013, hearing:
 - A. C-13-21E - Guardian Industries Corp

On December 24, 2013, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from December 24, 2013, until January 2, 2014. Said variance provided relief from specific requirements of District Rules 1080, 2070.7.0, 2201, 2520, 4001, 4101, and 4354 and allowed for the continued glass manufacturing with excess visible emissions while the exhaust stream bypasses the scrubber, electrostatic precipitator, and selective catalytic reduction so that maintenance can be performed on said equipment.

B. C-14-01E- PPG Industries Inc. Works #15

On January 3, 2014, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from January 4, 2014, until January 7, 2014. Said variance provided relief from specific requirements of District Rules 1080, 2070.7.0, 2201, 2520, 4001, and 4354 and allowed for the continued operation of the glass melting furnace and glass production without a certified SO_x continuous emissions monitoring system until it can be certified per the applicable parts of the Code of Federal Regulations, including, but not limited to a cylinder gas audit.
