5. The Central Region Hearing Board has heard and granted the following emergency variances since the June 17, 2015, hearing.

A. Docket C-15-15E - Guardian Industries Corp

On June 15, 2015, Hearing Board Chair, Jerry K. Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from June 15, 2015, until June 17, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4101, and 4354 and allowed for continued glass manufacturing with excess visible emissions while the exhaust stream bypasses the scrubber, EP, and SCR so that maintenance can be performed on the EP.

B. Docket C-15-16E – Granite Construction Coalinga

On July 1, 2015, Hearing Board Chair, Jerry K. Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from June 30, 2015, until July 29, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, and 4309 and allowed for continued operation of the subject dryer with excess CO and NO<sub>x</sub> emissions until the new fuel train can be installed and the emissions brought into compliance.

## C. <u>Docket C-15-18E</u> – Aera Energy, LLC

On July 17, 2015, Hearing Board Chair, Jerry K. Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from July 17, 2015, until July 22, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4401 and 4623, and allowed for the continued storage of VOC containing liquids at the Section 32 Dehydration facility without a functional or operating vapor recovery system.
