  - A. C-14-21E - Pacific Ethanol Madera LLC

On December 18, 2014, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from December 18, 2015, until January 17, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, and 2520 and allowed for the continued fermentation of ethanol while the RTO is down to replace the natural gas valve.

B. C-14-22E - PPG Industries Inc. Works #15

On January 2, 2015, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from December 30, 2014, until January 28, 2015. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4101, 4201, 4202, and 4354 and allowed for the continued operation of the glass melting furnace and glass production without the use of the CEMS/COMS and while the exhaust stream bypasses the electrostatic precipitator and wet scrubber.
