A. C-16-19E - Guardian Industries Corp

On August 23, 2016, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance for August 23, 2016. Said variance provided relief from specific requirements of District Rules 2201, 2070, 2520, and 4101 and allowed for continued glass manufacturing with excess visible emissions while the exhaust stream bypasses the emissions control system while GUARDIAN repairs the EP.

B. C-16-20E - CertainTeed Corporation

On September 6, 2016, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from September 6, 2016, to September 8, 2016. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4101, and 4354 and allowed for continued glass manufacturing with excess visible emissions while the exhaust stream bypasses the pre-conditioning chamber, caustic soda injection, EP, and CEMS while CERTAINTEED repairs the feeder grinder.
