11. The Central Region Hearing Board heard and granted the following emergency variances since the May 18, 2016, Hearing:

A. C-16-14E - Wellhead Power Panoche

On May 25, 2016, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from May 23, 2016, to June 10, 2016. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4001, and 4703 and allowed for the continued operation of the subject turbine without a certified CEMS until it can be replaced and certified.

B. C-16-16E - CertainTeed Corporation

On June 21, 2016, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance for June 22, 2016. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4101, and 4354 and allowed for continued glass manufacturing with excess visible emissions while the exhaust stream bypasses the pre-conditioning chamber, caustic soda injection, EP, and CEMS while CERTAINTEED repairs the EP fan bearing.
