A. C-17-06E - CertainTeed Corporation

On February 9, 2017, Hearing Board Chair, Mr. Jerry K Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance for February 10, 2017. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4101, and 4354 and allowed for continued glass manufacturing with excess visible emissions while the exhaust stream bypasses the pre-conditioning chamber, caustic soda injection, EP, and CEMS while CERTAINTEED cleans out the furnace EP cross duct.
