10. Stipulated Order of Abatement report:

A Stipulated Order of Abatement was granted by the Central Region Hearing Board on December 16, 2015, between the District and Agricultural Growers to allow the burning of orchard removal material in situations where no economically feasible option is available. No growers have entered into the stipulation since the June 20, 2018, hearing.

On August 1, 2018, Hearing Board Chair, Jerry Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from August 2, 2018, through August 13, 2018. Said variance provided relief from specific requirements of District Rules 2010, 2070, 2201, 2410, 2520, 4101, and 4354 and allowed for the continued glass manufacturing with excess emissions while the exhaust stream bypasses the scrubber, EP, and SCR so that maintenance can be performed on the EP.
