11. The Central Region Hearing Board heard and granted the following emergency variance since the September 18, 2019, hearing:

A. C-19-17E Ardagh Glass Inc.

On September 18, 2019, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from September 18, 2019, through September 25, 2019. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4101, and 4354, and allowed for continued glass manufacturing with excess visible emissions and SO_x emissions while the exhaust stream bypasses the electrostatic precipitator so that maintenance can be performed.
