Patrick Houlihan presented the District report. The original request submitted was for 72 hours of non-emergency use. Patrick stated that the petitioner came to them at a late date and asked for the hours to be increased to 120 hours. Amendment to page 3 to read 120 hours. Due to the increase in hours, the excess emissions were recalculated and changed to reflect the following: Page 2, 1,106 pounds of NO_X , changed to 1,900 pounds of NO_X , 27 pounds of PM changed to 60 pounds of PM and 120 pounds of CO changed to 240 pounds. On page 3 of the conditions, #1 strike out 72 hours and change to 120 hours; #4 strike out 1,106 pounds of NO_X and change to 1,900 pounds of NO_X ; #5 change from 27 pounds of PM to 60 pounds of PM, and #6 change from 120 pounds of PM to 240 pounds of PM.

James Waterman and Jerry Boren asked the petitioner for clarification regarding issues of the power exchange and what areas were affected in regards to business vs. residences.

Jerry Boren questioned the petitioner regarding the effect of noise from the generators on the residents in the area. The petitioner assured the Hearing Board that the residences and campgrounds are far enough away to not be affected by noise.

Jerry Boren asked the petitioner if consideration was given to the work possibly being done at night. The petitioner informed the Board that due to safety issues, this would not be an option due to darkness.

James Waterman asked about danger to the habitat and was assured that this had been looked into by a biologist and considered not a problem.
