Condition #4 changed to read that the excess ammonia slip shall not exceed 5 pounds per hour rather than 3 pounds per hour based on a 24 hour rolling average during the variance period.

A change will also be made to the facility's name to read Guardian Industries Corp, not corporation. The change will be made when decision is forwarded.

There were a few questions from the Board members regarding emissions and nearness to population. Questions addressed by Patrick Houlihan. Patrick explained visible appearances of plumes coming from the stacks and what they indicated.

The Petitioner responded to the District presentation stating it was accurate. Mr. Newell gave a brief explanation regarding how weather can affect the visible plume as seen above the stacks.

Mr. Boren asked the petitioner if they felt confident that they would be able to make the necessary correction without having to return to the Board to ask for a new ATC.

Mr. Newell responded that they are confident the manufacturer will be able to solve the issue. Mr. Newell briefly explained their expectations regarding the manufacturer's ability to achieve the goals Guardian Industries has asked of them.
