Patrick Houlihan presented the staff report. It was clarified to the Hearing Board members that the request is not associated with mechanical failure, replacement or repairs of pollution control equipment. Mr. Houlihan explained that the variance request is due to errors in the emission limits stated on the original ATC application. He also stated that Starwood Power will reapply to modify their ATC to get the correct start-up and shutdown emission levels. It will be determined by the Permits Division what is allowed.

Mr. Fair agreed with the staff report. He explained the startup process and how the equipment operates. He also mentioned that the facility was in error by not reviewing the limits on their permit and this should have been recognized prior to startup. It was also stated that the amount of emissions is high only at the very beginning of startup and that once the equipment heats up, the emissions are in compliance.

Mr. Houlihan informed the Hearing Board members that the facility was issued a NOV for the first month of operation for being in excess of allowable emissions.
