The Chair asked if there were any comments regarding the Minutes for March 20, 2013. Hearing no comments, the Chair declared the minutes were approved as submitted.

CertainTeed has requested a short variance from the applicable requirements of District Rules 1080, 2070.7.0, 2201, 2520, 4101, and 4354, in addition to conditions of the subject permits. The requested short variance period would be a consecutive 48-hour period to occur sometime between May 20, 2013, and June 5, 2013, inclusive. If granted, the variance would allow the exhaust stream from the glass melting furnace to bypass the pre-conditioning chamber and EP while the proposed maintenance is conducted.

Mr. Boren asked how opacity is measured. Mr. Houlihan explained opacity is measured visually. He added persons measuring opacity at facilities must attend a training every six months and be re-certified by ARB.

Mr. Hartwig asked for the purpose of a person visually inspecting opacity at a facility. Mr. Houlihan explained ARB requires quantification on every variance of emissions produced.

Mr. Mulligan expressed concern for the facility ceasing operations should there be a complaint be received by the District. Mr. Houlihan explained ceasing operations would be difficult. Mr. Boren added that historically the District receiving one complaint would not warrant action, but would lead to more observations and analysis by staff.

Mr. Curtin thanked Mr. Houlihan for an excellent presentation.

Public Comments: None

Having decided the petition has met the required findings, on motion of Mr. Mulligan and seconded by Mr. Hartwig, unanimously passed, the petitioner was granted a short variance.

Patrick Houlihan presented the Staff Report.

PNA is requesting a short variance from the requirements of District Rules 2070.7.0, 2201, 2520, 4101, and 4202 in addition to conditions of the subject PTOs. The requested short variance period would be for a non-consecutive 30-day period to occur sometime between May 15, 2013, and July 26, 2013, inclusive. If granted, the variance would allow for the subject baghouses to be shut down for the appropriate maintenance.

Mr. Mulligan requested confirmation that only one baghouse will be shut down at a time. Mr. Houlihan responded affirmatively. Mr. Mulligan asked if employees will be in harm's way due to dust, fines and visible emissions not being vacuumed into the baghouses. Mr. Houlihan stated staff has made the facility aware of the issue.

Mr. Boren asked if a penalty is applied to the excess emissions. Mr. Houlihan explained the District is in attainment for PM10 so there is no mitigation fees assessed.

Mr. Wong explained employees will not be near the baghouse points where the vacuum is not active. Mr. Mulligan asked if there will be visible warning signs to caution employees about the areas in question. Mr. Wong responded affirmatively.

Mr. Wong thanked Mr. Houlihan for the presentation.

Public Comments: None

Having decided the petition has met the required findings, on motion of Dr. Goodwin and seconded by Mr. Hartwig, unanimously passed, the petitioner was granted a short variance.

Patrick Houlihan presented the Staff Report.

Starwood has requested in interim variance, to be followed by a short variance, from the applicable requirements of District Rules 2070.7.0, 2201, and 2520 in addition to the applicable conditions of the subject Permits to Operate (PTOs). The requested interim variance period would be from May 9, 2013, until July 3, 2013, inclusive, or until the Central Region Haring Board as heard the petition for the short variance, whichever occurs first. If granted, the variance would allow the operation of the subject turbines with excess NH₃ until a solution can be found to return NH₃ emissions to compliance.

Mr. Boren asked if the facility was currently operating. Mr. Fair said no, but explained the facility is available to operate. Mr. Boren asked if the facility has operated during the current year. Mr. Fair responded affirmatively.

Mr. Mulligan asked what the ramifications are if the facility does not operate when asked to. Mr. Fair explained the facility has a contract with Pacific Gas & Electric (PG&E) that will apply penalties for not operating. He added the facility must maintain certain availability and any percent dropped below the available there is a directly correlated penalty to the capacity payment.

Mr. Hartwig asked how many hours the facility expects to run during the interim variance. Mr. Fair explained the facility is expected to operate very few hours if at all.

Mr. Mulligan asked how much advanced notice does the facility obtain from PG&E. Mr. Fair responded the facility will be informed approximately ten minutes prior to the

facility needing to operate. He added the facility is dispatched by the California Independent System Operator (Cal-ISO) and the facility has a ten-minute start time. Mr. Mulligan asked if the facility is informed of the length of time the facility will need to operate when dispatched. Mr. Fair explained normally the facility is informed of the length of time the facility will operate, but it is not required.

Public Comments: None

Having decided the petition has met the required findings, on motion of Mr. Mulligan and seconded by Dr. Goodwin, unanimously passed, the petitioner was granted an interim variance.
