Petitioners: Kayhan Hazrati and Christopher Campbell

Patrick Houlihan presented the Staff Report.

Sun-Maid has requested a regular variance from the applicable requirements of District Rules 2070.7.0, 4101 and Section 41701 of the CH&SC, in addition to the applicable condition of the subject Permit to Operate (PTO). The requested variance period would be from October 16, 2013, until September 30, 2014. If granted, the variance would allow the continued operation of the subject dehydrator with excess visible emissions until measures can be implemented to achieve compliance.

Mr. Houlihan presented a photo of the facility.

The Vice-Chair called for a short recess due to technical difficulties at 10:25 a.m. The Hearing reconvened at 10:30 a.m. with all Hearing Board members present.

Dr. Goodwin asked the length of the chain. Mr. Hazrati explained the two separate chains are approximately 30 feet each and 6 feet wide. Dr. Goodwin asked how the chains are cleaned. Mr. Hazrati stated the chain is cleaned by water spray and brush within the equipment.

Mr. Mulligan asked the age of the equipment. Mr. Hazrati stated the equipment has been in place for approximately 4 years.

Having decided the petition has met the required findings, on motion of Dr. Goodwin and seconded by Mr. Hartwig, unanimously passed, the petitioner was granted a regular variance.

Petitioners: Aric Murfield, Lance Ericksen and Trey Caylor in Bakersfield

Patrick Houlihan presented the Staff Report.

CUSA has requested a short variance from the applicable requirements of District Rules 2070.7.0, 2201, 2520, and 4623 in addition to conditions of the subject Permits to Operate (PTOs). The requested short variance period would be for a consecutive 45-day period to occur sometime between December 2, 2013, and March 1, 2014, inclusive. If granted, the variance would provide relief to CUSA from having to incinerate the tank VRS vapors in the steam generators as required by the conditions of the permits. In addition, it would allow CUSA to continue to store VOC containing liquids in the subject tanks without a functional or operating VRS.

Mr. Houlihan presented a photo of the facility.

Mr. Ericksen explained the steam plants also have the designation of 25D due to physical location. Mr. Murfield added the reason for the series of variances is for coordinated projects. Mr. Caylor had no comment.

Having decided the petition has met the required findings, on motion of Dr. Goodwin and seconded by Mr. Hartwig, unanimously passed, the petitioner was granted a short variance.

Petitioners: Phillip Newell and Besrat Solomon

Patrick Houlihan presented the Staff Report.

Guardian has requested a short variance from the applicable requirements of District Rules 1080, 2070.7.0, 2201, 2520, 4001, 4101, and 4354 in addition to the applicable conditions of the subject PTOs. The requested short variance would be for a consecutive six-day period to occur sometime between November 10, 2013, and January 15, 2014, inclusive. If granted, the variance would allow the continued operation of the glass melting furnace, and continued glass production, with excess visible emissions while Guardian shuts down the scrubber, EP, SCR and places the CEMS into maintenance mode, to perform required maintenance on the control equipment.

Mr. Mulligan asked if the facility's permit be amended to allow for visible emissions. Mr. Houlihan explained the permit cannot be amended due to a District Rule superseding another District Rule. Mr. Hayashi added the District cannot have rules less stringent than what the state requires.

Having decided the petition has met the required findings, on motion of Dr. Goodwin and seconded by Mr. Mulligan, unanimously passed, the petitioner was granted a short variance.
