Mr. Moore presented the Staff Report.

Guardian has requested a short variance from the applicable requirements of District Rules 2010, 2070, 2201, 2520, 4101, and 4354 in addition to the applicable conditions of the subject permits. The requested short variance will be for a consecutive 72 hour period to occur sometime starting February 17, 2016, through March 31, 2016. If granted, the variance will allow the continued operation of the glass melting furnace, and continued glass production, with excess visible emissions while Guardian shuts down the scrubber, EP, and SCR, in order to clean and inspect the EP.

Mr. Mulligan asked if the procedure can be scheduled when the air quality will not be impacted. Mr. Moore explained the maintenance schedule is limited to the production schedule and the buildup on the EP. Ms. Solomon explained an emergency variance was granted earlier due to broken equipment and submitted the petition in case something goes wrong.

Mr. Hartwig asked how likely the variance would be used if approved. Ms. Solomon explained the variance requested will be used in a worst case situation.

Aera has requested a short variance from the applicable requirements of District Rules 2070, 2201, 2520, 4401, and 4623, in addition to applicable conditions of the subject permits. The requested short variance would be for a consecutive 24-hour period to occur sometime between March 1, 2016, and May 23, 2016, inclusive. If granted, the variance would allow Aera to continue to store VOC containing liquids at the Section 32 Dehydration Facility without a functional or operating VRS while they install tie-ins for the new pumps that will be installed.

Coalinga Cogeneration Facility (CCF) has requested a short variance from the applicable requirements of District Rules 1080, 2070, 2201, 2520, 4001, and 4623, in addition to applicable conditions of the subject permits. The requested short variance would be effective from February 17, 2016, through May 16, 2016, inclusive. If granted, the variance would allow CCF to continue operating the combustion turbine generator without a certified continuous emissions monitoring system (CEMS) while the CO portion of it is being upgraded

Mr. Mulligan asked the operation schedule. Mr. Barnes explained the facility runs 7 days a week, 24 hours a day.

Mr. Hartwig asked the cost of a new CEMS unit. Mr. Barnes responded the analyzer is being replaced by one that is currently in stock by the facility. He approximated the cost to be \$10.000-\$20.000.
