Mr. Moore presented the Staff Report.

Guardian Industries, LLC has requested a short variance from the applicable requirements of District Rules 2070, 2201, 2520, 4101, 4354, and California Health and Safety Code (CH&SC) section 41701 in addition to the applicable conditions of the subject permits. The requested short variance would be for a consecutive 10 day period to occur sometime between March 1, 2022, and April 30, 2022, inclusive. If granted, the variance would allow the continued operation of the regenerative glass melting furnace and glass manufacturing with excess NOx, SOx, CO and visible emissions while the work is performed.

Dr. Goodwin asked for estimated time that the visible emissions could be high during the cleanout process. Mr. Roach responded it would be about 15 minutes if bypass mode is needed during the cleanout. He added that bypass was not part of the normal cleanout process and they would do their best to avoid it. Dr. Goodwin asked why Guardian asked for additional time this year for the cleanout process, as opposed to the past. Mr. Roach responded that Guardian has a contingency plan in place, to allow for unexpected staff absences due to Covid-19.

Mr. Moore clarified that based on similar variance requests, this variance request falls under a normal timeframe for similar processes.

Mr. Robertson clarified the actual burn time on the auxiliary burners. Mr. Roach responded it would be approximately 5 days of continuous burning.
